6 **cv-02937-PJH; entitled Jo-Theresa Elias-Jackson v. City and County of San Francisco;**  
7 **the lawsuit involves an employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Jo-Theresa Elias-Jackson v. City and  
12 County of San Francisco, United States District Court, Northern District of California, Case  
13 No. 3:21-cv-02937-PJH by the payment of \$92,000. The lawsuit involves an employment  
14 dispute.
