3 **Ordinance authorizing settlement of the lawsuit filed by Margarita Herrera against the**  
4 **City and County of San Francisco for \$650,000; the lawsuit was filed on July 30, 2019,**  
5 **in San Francisco Superior Court, Case No. CGC-19-578026; entitled Margarita Herrera**  
6 **v. City and County of San Francisco; the lawsuit involves an employment dispute.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Margarita Herrera v. City and County  
11 of San Francisco, San Francisco Superior Court, Case No. CGC-19-578026 by the payment  
12 of \$650,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on July
