12	WHEREAS, Wayne Garcia is seeking the issuance of a Type 42 on-sale beer							
13	and wine public premises license and the transfer of a Type 20 off-sale beer and wine							
14	license from Ferry Building, Market Place, Unit 33, the Embarcadero, for DIGWines,							
15	LLC, located at 1005 Minnesota Street; and,							
16	WHEREAS, The City Planning Department has verified that the area is properly							
17	zoned; and,							
18	WHEREAS, The Police Department recommends that the liquor license							
19	application be approved with conditions; now, therefore, be it							
20								
21	RESOLVED, That in accordance with Section 23958.4 of the California Business							
22	and Professions Code, the Board of Supervisors of the City and County of San							
23	Francisco hereby determines for the foregoing reasons that the issuance of a Type 42							
24	on-sale beer and wine public premises license and the transfer of a Type 20 off-sale							
25	beer and wine license from Ferry Building, Market Place, Unit 33, the Embarcadero, to							

Wayne Garcia for DIGWines, LLC, located at 1005 Minnesota Street, will serve the 1 public convenience or necessity of the people of the City and County of San Francisco. 2 Conditions: (1) The two licenses, type 20 and 42, shall operate in conjunction 3 4 with one another and shall not be separated. (2) Sales, service and consumption of 5 alcoholic beverages shall be permitted only between the hours of 11:00 a.m. to 9:00 6 p.m. daily. (3) Service and consumption of alcoholic beverages shall be permitted only 7 at the tasting bar as depicted on ABC-257, except for private events that are closed to 8 the public with signage posted. (4) The tasting bar must be sectioned off with "No One 9 Under 21 is Allow" sign clearly posted. (5) Service and consumption of alcoholic 10 11 beverages must be limited to one (1) ounce pours per serving. (6) The sale of any beer 12 and/or malt product(s) is strictly prohibited. (7) Noise ("noise is defined as any raucous 13 sound that is produced in such a manner or to such a degree as to disturb the peace, 14 quiet, and comfort of persons in the neighborhood") shall not be audible beyond the 15 area under the control of the licensee. (8) The petitioner shall be responsible for 16 maintaining free of litter the area adjacent to the premises over which they have control. 17 (9) The exterior of the premises shall be equipped with lighting of sufficient power to 18 19 illuminate and make easily discernible the appearance and conduct of all persons on or 20 about the premises. Additionally, the position of such lighting shall not disturb the 21 normal privacy and use of any neighboring residences. (10) Loitering (loitering is 22 defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on 23 any sidewalks or property adjacent to the licensed premises under the control of the 24
