6	WHEREAS, Board Rule 3.30 allows the Board, by Motion, to create Select Committees
7	after such Motion has been referred to the Rules Committee for public hearing and

13	MOVED, Pursuant to Board Rule 3.30, that the Board of Supervisors of the City and
14	County of San Francisco, hereby amends its Rules of Order to create a new Rule 3.32, as
15	follows:
16	3.32. Homelessness and Behavioral Health Select Committee. The Homelessness
17	and Behavioral Health Select Committee shall be referred legislation and requests for
18	hearings concerning the coordinated efforts of City Departments and State and Federal
19	Agencies tasked with addressing the City's response to homelessness and implementation of
20	behavioral health interventions and treatment, including fiscal matters with direct and
21	exclusive fiscal impact on homeless individuals, service providers, and medical and
22	behavioral health treatment facilities that are not part of the annual budget appropriation
23	process. When the subject matter of legislation concerns these subjects and overlaps with the
24	scope of other committees, the President shall determine and designate the legislation. The

1	Select Committee shall consist of three members of the Board of Supervisors designated by
2	the President. This Select Committee shall terminate on January 7, 2025.
