3 **Ordinance authorizing settlement of the lawsuit filed by Francisco Valle against the**  
4 **City and County of San Francisco for \$1,950,000; the lawsuit was filed on August 30,**  
5 **2021, in United States District Court-Northern District of California, Case No. 21-cv-5636**  
6 **EMC; entitled Francisco Valle v. Paolo Morgado, et al.; the lawsuit involves alleged civil**  
7 **rights violations including *Brady* violations and fabrication of evidence in violation of**  
8 **the Fourteenth Amendment.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Francisco Valle v. Paolo Morgado, et  
13 al, United States District Court-Northern District of California, Case No. 21-cv-5636 EMC by  
14 the payment of \$1,950,000. The lawsuit involves alleged civil rights violations including *Brady*  
15 violations and fabrication of evidence in violation of the Fourteenth Amendment.

16 Section 2. The above-named action was filed in United States District Court-Northern  
17 District of California on August 30, 2021, and the following parties were named in the lawsuit:  
18 plaintiff: Francisco Valle; defendants: Paulo Morgado, Dennis Cravalho, City and County of  
19 San Francisco, Angela Roude, Michael Gaynor, Michael Philpott, Jennifer Jackson, Robert
