3 **Resolution condemning the passage of “Red-Baiting” House Concurrent Resolution 9,**
4 **and urging Congress not to engage in, vote for, or otherwise support fearmongering**
5 **and red-baiting by the federal government.**

7 WHEREAS, On January 25, 2023, Republican Maria Elvira Salazar (R-FL) introduced
8 House Concurrent Resolution 9 (“the Resolution”), “Denouncing the Horrors of Socialism,” in
9 the United States House of Representatives; and

10 WHEREAS, On February 1, 2023, the Resolution passed by a bipartisan vote of 328-
11 86; and

12 WHEREAS, The Resolution inaccurately attributed several atrocities to socialism and
13 socialist ideals; and

14 WHEREAS, The Resolution cites a litany of “socialist ideologues” and claims that
15 “socialism has repeatedly led to famine and mass murders, and the killing of over
16 100,000,000 people worldwide”; and

17 WHEREAS, The Resolution states that “Congress denounces socialism in all its forms,
18 and opposes the implementation of socialist policies in the United States of America”; and

19 WHEREAS, Red-baiting is defined as the act of harassing or persecuting someone on
20 account of known or suspected sympathies for communist, socialist, or similar left-aligned
21 ideologies; and

22 WHEREAS, Red-baiting has historically been used in the United States of America to
23 disenfranchise, silence, and jail people for political and anti-worker purposes; and

1 WHEREAS, Socialism has deep roots all over the world, and socialist ideas have
2 motivated many leaders to seek better conditions for our most vulnerable residents in the
3 United States and worldwide; and

4 WHEREAS, Martin Luther King, Jr., Angela Davis, Bayard Rustin, W.E.B. Du Bois,
5 Mother Jones, Dorothy Day, Paul Robeson, Langston Hughes, James Baldwin, Cesar
6 Chavez, and countless other celebrated leaders were unapologetic about their socialist ideals;
7 and

8 WHEREAS, It is often stated that San Francisco is a union town, with a rich tradition of
9 socialist organizing that lives on to the present in the struggle for workers' rights; and

10 WHEREAS, The United States has implemented various essential programs and
11 changes to its laws based on socialist ideals, including public housing, public education,
12 public libraries, the United States Postal Service, Medicare, and other similar programs; and

13 WHEREAS, It is a disservice to the legacies of socialist leaders, workers, and socialist-
14 inspired programs that exist today to allow this type of misleading redbaiting to permeate once
15 again through the Capitol; now, therefore, be it

16 RESOLVED, That the San Francisco Board of Supervisors ("the Board") condemns
17 House Concurrent Resolution 9; and, be it

18 FURTHER RESOLVED, That the Board urges Congress not to engage in, vote for, or
19 otherwise support fearmongering and red-baiting; and, be it

20 FURTHER RESOLVED, That the Board calls on Congress, President Joe Biden, and
21 Vice President Kamala Harris to stand against red-baiting by the federal government; and, be
22 it

23 FURTHER RESOLVED, That the Clerk of the Board will send a copy of this Resolution
24 to Congresswoman Nancy Pelosi, Congressman Kevin Mullin, Senator Dianne Feinstein,

1 Senator Alex Padilla, President Joe Biden, and Vice President Kamala Harris upon its
2 passage.

CONCURRENT RESOLUTION

Denouncing the horrors of socialism.

Whereas socialist ideology necessitates a concentration of power that has time and time again collapsed into Communist regimes, totalitarian rule, and brutal dictatorships;

Whereas socialism has repeatedly led to famine and mass murders, and the killing of over 100,000,000 people worldwide;

Whereas many of the greatest crimes in history were committed by socialist ideologues, including Vladimir Lenin, Joseph Stalin, Mao Zedong, Fidel Castro, Pol Pot, Kim Jong Il, Kim Jong Un, Daniel Ortega, Hugo Chavez, and Nicolás Maduro;

Whereas tens of millions died in the Bolshevik Revolution, at least 10,000,000 people were sent to the gulags in the Union of Soviet Socialist Republics (USSR), and millions more starved in the Terror-Famine (Holodomor) in Ukraine;

Whereas between 15,000,000 and 55,000,000 people starved to death in the wake of famine and devastation caused by the Great Leap Forward in China;

Whereas the socialist experiment in Cambodia led to the killing fields in which over a million people were gruesomely murdered;

Whereas up to 3,500,000 people have starved in North Korea, dividing a land of freedom from a land of destitution;

Whereas the Castro regime in Cuba expropriated the land of Cuban farmers and the businesses of Cuban entrepreneurs, stealing their possessions and their livelihoods, and exiling millions with nothing but the clothes on their backs;

Whereas the implementation of socialism in Venezuela has turned a once-prosperous nation into a failed State with the world's highest rate of inflation;

Whereas the author of the Declaration of Independence, President Thomas Jefferson, wrote, "To take from one, because it is thought that his own industry and that of his fathers has acquired too much, in order to spare to

others, who, or whose fathers have not exercised equal industry and skill, is to violate arbitrarily the first principle of association, the guarantee to every one of a free exercise of his industry, and the fruits acquired by it.”;

Whereas the “Father of the Constitution”, President James Madison, wrote that it “is not a just government, nor is property secure under it, where the property which a man has in his personal safety and personal liberty, is violated by arbitrary seizures of one class of citizens for the service of the rest”; and

Whereas the United States of America was founded on the belief in the sanctity of the individual, to which the collectivistic system of socialism in all of its forms is fundamentally and necessarily opposed: Now, therefore, be it
