**Public Convenience or Necessity Determinations** 

## Issuance or Transfer of Certain Liquor Licenses in the City and County of San Francisco

California Business and Professions Code, Section 23958.4

To request a PC or N determination, an applicant must provide the following information by letter:

- Applicant's name and contact information, including a daytime phone number and email address;
- 2) The name and address for the applicant's business;
- The applicant's mailing address (if different from the above);
- The license type the applicant is seeking from the California Department of Alcoholic Beverage Control, and whether the license will be a new issuance or a transfer of an existing license;
- 5) The proposed business hours of operation;
- 6) When and how the applicant filed the application for the liquor license with the California Department of Alcoholic Beverage Control;
- 7) When and how the applicant completed the noticing requirements for the liquor license, pursuant to state law; and
- 8) An explanation for how the license will serve the public convenience or necessity in the neighborhood and city-wide.

NOTE 1: Applicants must first apply for a license with the California Department of Alcoholic Beverage Control, before requesting a determination of public convenience or necessity.

NOTE 2: The letter requesting a determination of public convenience or necessity must be signed by the applicant.
