[Settlement of Lawsuit - National Union - Receipt of \$925,000]

Ordinance authorizing settlement of the lawsuit entitled *City and County of San Francisco v. National Union, etc., et al.,* United States District Court, N.D. Cal., Case No: CV-103385-SI, arising from an insurance dispute involving policies issued by National Union Fire Insurance Company of Pittsburgh and sister company Chartis Specialty Insurance Company to the San Francisco Public Utilities Commission, calling for payment of \$925,000 from National Union to the City and County of San Francisco and including other material terms of said settlement; and appropriating settlement proceeds.

Be it ordained by the People of the City and County of San Francisco:

Section 1. The City Attorney is hereby authorized to settle the action entitled *City and County of San Francisco v. National Union, etc., et al.,* United States District Court, N.D. Cal., Case No: CV-103385-SI, by payment of \$925,000 from National Union Fire Insurance Company of Pittsburgh, PA ("National Union") to the City and County of San Francisco. In addition, the settlement shall contain the following material terms: (1) National Union will have no further obligations under Policy Nos. 9331863, 9332415, 9333054, 7043168 and Chartis Specialty Insurance Company ("Chartis") will have no further obligations under Excess Liability Policy No. 7411476 ("Policies") for claims arising out of or related to the following actions: *Mitchell Engineering v. City and County of San Francisco*, U.S.D.C., Northern District of California, Case No. CV 08-4022 - SI; *Thunder Electric Inc. v. Mitchell Engineering, Inc., et al.*, California Superior Court, San Francisco County, No. CGC - 06-458051; *Mitchell Engineering, Inc. v. City and County of San Francisco*, California Superior Court, San Francisco County, No. CGC-07-468361; *Mitchell Engineering v. City and County of San Francisco, et al.*, California

1	Superior Court, Alameda County, No. RG 0733 9056; Bay Area Reinforcing v. Mitchell

13	seeking to enforce the settlement, the prevailing party shall recover reasonable attorneys' fees
14	and costs.
15	Section 2. Settlement proceeds of \$925,000 are herein appropriated in a like amount
16	to fund the SFPUC's attorneys fees and legal expenses related to this settlement agreement,
