8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled William Bailey v. City and County of  
11 San Francisco, San Francisco Superior Court, Case No. CGC-20-587323 by the payment of  
12 \$52,500. The lawsuit involves an employment dispute.

13 Section 2. The above-named action was filed in San Francisco Superior Court on  
14 October 27, 2020, and the following parties were named in the lawsuit: Plaintiff: William
