I have a strong background in computer technology, journalism, and media. Thus, I've had a front-row seat to the development of enhanced digital technology that should make privacy and open-government advocates extremely wary. The degree of surveillance and cloaking possible today is exponentially greater than just a year ago. Surveillance is on the rise and free, public access to government decision making is waning. The startup company I work for specializes in these areas and has developed the capability, for good or bad, to render any computing environment 100% secure from the effects of hacking, viruses, and spyware.

As a journalist and separately as a political organizer, I have witnessed first-hand how closed government hearings and sessions weaken our democratic institutions dramatically. I don't believe this is a Democrat vs. Republican issue. It's not a liberal vs. conservative problem. I welcome a debate on the merits of any policy issue and any resulting compromise. I am writing to express my *supreme* interest in serving on the San Francisco Sunshine Ordinance Task Force, as an appointee to one of its vacant seats. I believe that my skills, experience, and passions are characterized by a high degree of congruence with the criteria you are looking for in prospective members of the Task Force.

I currently work at MAPLight.org, a nonprofit, nonpartisan organization based in Berkeley that seeks to reveal the connections between campaign contributions and legislative outcomes, making our findings freely available to the public, and seeking to inform as many citizens as possible about their lawmakers' voting records as well as the efforts of special interests seeking to influence legislative decisions. At the moment, we focus on the California State Legislature as well as U.S. Congress, so I am well versed in the legislative processes of both the state of California and the Federal Government.

I have a great deal of practice in monitoring current legislative affairs and news events in order to pinpoint specific issues that are worthy of illumination so that they become more transparent to the public. Through my work with the communications team at MAPLight.org, I have gained experience responding to requests from journalists and citizens to investigate specific issues, pieces of legislation, and actions of particular lawmakers, generating rigorously and objectively researched reports and disseminating them widely for public consumption.

Even prior to my employment at MAPLight.org, transparency was an issue of the utmost importance to me. While serving as a member of the Harvard First-Year Outdoor Program's Steering Committee, which had historically been a fairly closed and exclusive governing body, I made it a priority to increase the visibility of our decision-making process to the program's broader community, proposing the adoption of an open application process for appointments to the program's leaderships positions (as opposed to the Steering Committee's self-generated selection of appointees, which was the system in place when I began my service) and helped to develop a blog documenting the proceedings of committee meetings for program members to view.

With each passing day, my interest in and commitment to transparency grows stronger. I am thoroughly convinced that it is one of the highest ideals we can strive for, in large part because I know it is a vital element of a healthy and effective democratic government. Citizens must have access to information if they are to make the kind of informed decisions necessary to keep representative government responsive to the interests of its constituents, as it is intended to be.

The unfortunate truth is that, at this moment in time, there are far too many instances in which this is not the case. That said, the work of groups like the Sunshine Ordinance Task Force fills me with hope that this is not an inevitability – that together, citizens can bring about a government that is ever more accessible to its people.

I would be truly honored to have the opportunity to contribute to that effort here in San Francisco, and I promise you that I will bring everything that I am to the achievement of its end.

Added by Board of Supervisors' Ordinance No. 265-93 (Added Admin. Code Section 67.30); amended by Ordinance Nos. 118-94, 432-94, 287-96, 198-98, 387-98, and by Proposition G adopted November 2, 1999.

Board Qualifications:

The Sunshine Ordinance Task Force 2000 consists of a total of thirteen members, eleven of whom are appointed by the Board of Supervisors. The Mayor or his/her designee, and the Clerk of the Board of Supervisors or his/her designee serve as non-voting members. All members must have experience and/or demonstrated interest in the issues of citizen access and participation in local government. The City Attorney shall serve as legal advisor to the Task Force.

The members are drawn from the following categories: two appointed from names submitted by local chapter of the Society of Professional Journalists, one an attorney and one a local journalist; one appointed from the press or electronic media; one appointed from names submitted by the local chapter of the League of Women Voters; four members of the public who have demonstrated interest in or have experience in the issues of citizen access and participation in local government; two members of the public experienced in consumer advocacy; one appointed from names submitted by New California Media, to be a journalist from a racial/ethnic-minority-owned news organization.

The term of each appointive member shall be two years unless earlier removed by the Board of Supervisors. In the event of such removal or vacancy during the term of office of any appointive member, a successor shall be appointed for the unexpired term of the office vacated.

At all times, the Task Force shall include at least one member who shall be a member of the public who is physically handicapped and who has demonstrated interest in citizen access and participation in local government.

The Task Force shall advise the Board of Supervisors and provide information to other City departments on appropriate ways in which to implement Chapter 67 of the Administrative Code. The Task Force shall develop appropriate goals to ensure practical and timely implementation of Chapter 67; propose to the Board of Supervisors amendments to Chapter 67; report to the Board of Supervisors at least once annually on any practical or policy problems encountered in the administration of Chapter 67; make referrals to a municipal office with enforcement power under the Sunshine Ordinance or under the California Public Records Act and the Brown Act whenever it concludes that any person has violated any provisions of this ordinance or the Acts.

In addition to regular Task Force meetings, Task Force members are expected to participate in committee work.

Reports: Receive and review the Annual Report of the Supervisor of Public Records and may request additional reports or information as it deems necessary. Shall issue public reports as it sees fit, issue public reports, evaluating compliance with this ordinance and related California laws by the City or any Department, Officer, or Official thereof.
