3 **Ordinance authorizing settlement of the lawsuit filed by Andrea Cervantes against the**  
4 **City and County of San Francisco for \$400,000; the lawsuit was filed on August 10,**  
5 **2020, in San Francisco Superior Court, Case No. CGC-20-586083; entitled Andrea**  
6 **Cervantes v. City and County of San Francisco et al.; the lawsuit involves an**  
7 **employment dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Andrea Cervantes v. City and County  
12 of San Francisco et al., San Francisco Superior Court, Case No. CGC-21-589457, by the  
13 payment of \$400,000. The lawsuit involves an employment dispute.

15 Section 2. The above-named action was filed in San Francisco Superior Court on  
16 August 10, 2020, and the following parties were named in the lawsuit: Plaintiff: Andrea  
17 Cervantes; Defendants: City and County of San Francisco; Cheryl Sperry; Tania Fokin.
