3	Resolution adding the Commemorative Street Name "Emperor Norton Place" to the 600
4	block of Commercial Street in recognition of his contribution to San Francisco as a
5	celebrated figure in American history.

7	WHEREAS, Emperor Norton, also known as Joshua A. Norton, was a historical figure
8	who lived in San Francisco in the mid-19th century. He declared himself the Emperor of the
9	United States and Protector of Mexico in 1859, and held this self-proclaimed title until his
10	death in 1880; and
11	WHEREAS, Emperor Norton, is a celebrated example of individualism and eccentricity.
12	He rejected the conventions of his time and created his own identity, challenging the norms
13	and expectations of society. His unusual behavior, including issuing his own currency and
14	decrees, inspired many people and made him a beloved figure in San Francisco; and
15	WHEREAS, Norton was born in England but spent most of his early life in South Africa
16	Leaving Cape Town, probably in late 1845, he arrived in San Francisco in late 1849, and
17	subsequently lived in a boarding house called the Eureka Lodgings at 624 Commercial St.,
18	from 1863-1880; and
19	WHEREAS, For the first few years after arriving in San Francisco, Norton made a
20	successful living as a commodities trader and real estate speculator. However, he was
21	financially ruined following a failed bid to corner the rice market during a shortage prompted
22	by a famine in China; and
23	WHEREAS, Norton had no formal political power; but nevertheless, was treated
24	deferentially in San Francisco, and currency issued in his name was honored in some
25	establishments that he frequented. Some considered Norton to be insane or eccentric, but

1	residents of San Francisco enjoyed his imperial presence and took note of his frequent
2	newspaper proclamations; and
3	WHEREAS, On January 8, 1880, Norton collapsed at the corner of California and
4	Dupont (now Grant Avenue) streets and died before he could be given medical treatment.
5	According to the San Francisco Chronicle, upwards of 10,000 people lined the streets of San
6	Francisco to pay him homage at his funeral; and
7	WHEREAS, Norton has been immortalized as the basis of characters in the literature of
8	Mark Twain, Robert Louis Stevenson, Christopher Moore, Morris and and René Goscinny,
9	Selma Lagerlöf, Neil Gaiman, Mircea Cărtărescu and Charles Bukowski; and
10	WHEREAS, Today, Emperor Norton is a beloved figure in San Francisco, remembered
11	as a humanitarian and visionary. He was known to advocate for equality for all minorities,
12	extending the vote to women, and proposed the San Francisco and Oakland Bay Bridge, the
13	Transbay Tube, the United Nations, and more; and
14	WHEREAS, Emperor Norton's legacy also highlights the importance of mental health
15	and how society should treat those suffering from mental illness. His case is a reminder that
16	mental health disorders should not be a source of shame or isolation, and that people with
17	these disorders can still make significant contributions to their communities; now therefore, be
18	it
19	RESOLVED, That to celebrate the legacy and contributions of Emperor Norton, there
20	shall be an honorary naming of "Emperor Norton Place" on Commercial Street between
21	Montgomery Street and Kearny Street; and, be it
22	FURTHER RESOLVED, That the Department of Public Works is directed to add the
23	honorary street name to its official list of Commemorative Street Names in accordance with
24	Public Works Code, Section 789 et seq.
