[Gift Acceptance - ArtCare Program - \$10,000]

Resolution authorizing the Arts Commission to accept and expend a donation from the Arnhold Foundation in the amount of \$10,000 for general operating support of the ArtCare Program.

WHEREAS, The 1969 Art Enrichment Ordinance was adopted to enable up to two percent of every San Francisco public works project to be allocated to the commissioning or acquisition of artwork for that site-specific project; and

WHEREAS, No City funds are allocated to the maintenance, repair and restoration of these artworks that compromise the Civic Art Collection; and

WHEREAS, The Civic Art Collection has 3,500 objects worth approximately \$93 million; and

WHEREAS, The Civic Art Collection's work includes 19th century historic monuments as well as 40-year-old contemporary artwork located throughout San Francisco; and

WHEREAS, If these artworks are not maintained the City will lose these asset; and WHEREAS, ArtCare was launched in spring 2010 to raise individual and philanthropic dollars to create a pool of funds for the maintenance, repair and restoration of the aging Civic Art Collection; therefore be it

RESOLVED, That the Board of Supervisors allows accepting and expending of this received Arnhold Foundation donation, which has no grant period restrictions, to the Arts Commission, waiving inclusion of indirect costs; and, be it

FURTHER RESOLVED, That the Arts Commission has no ASO amendments, this donation will be carried out in accordance with all grant requirements and may be spent and reported upon accordingly.
