5 **2020, in San Francisco Superior Court, Case No. CGC-20-585768; entitled Christopher**
6 **Wirowek v. City and County of San Francisco; the lawsuit involves an employment**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled **Christopher Wirowek v. City and**
12 **County of San Francisco**, San Francisco Superior Court, Case No. CGC-20-585768 by the
13 payment of \$436,000. The lawsuit involves an employment dispute.
