Dear Budget & Appropriations Committee:

Please make room for climate on the 2024 ballot.

We, the undersigned, appreciate your participation in the March 15th hearing at City Hall to discuss recommendations in the Berkeley Center for Law, Energy & the Environment (CLEE) report. But you don't seem to be taking these recommendations seriously enough. As a reminder, the ones concerning bonds - unanimously endorsed by the Board of Supervisors in December - are:

- A dedicated \$300-500 million General Obligation bond for building decarbonization, to fund efficiency and electrification retrofits for existing residential buildings;
- Increasing the size of the upcoming affordable housing GO bond by \$50-100 million to fund the San Francisco Housing Accelerator Fund for Climate Action Plan-aligned housing investment;
- A dedicated \$300-500 million transportation GO Bond to fund public transit, active transportation, and electric vehicle charging infrastructure.

The above could be three separate GO bond proposals, or instead a single, comprehensive GO bond for building decarbonization, housing, and transportation investments. A bond could help replace the thousands of trees lost in this winter's storms: one of the most tangible climate change impacts the City has experienced.

YOU have the power to craft the climate bond that seems best to you for the ballot in 2024. The ballot must provide meaningful funding to implement our city's Climate Action Plan and achieve our climate goals in time. Please don't wait.

According to the recent IPCC Synthesis Report, only if we act NOW can we fend off the worst

damage and secure a livable, sustainable planet for generations to come. This does not mean only trying to prepare in advance of the inevitable next disaster. It means doing all we can to address the actual cause of climate change: reducing greenhouse-gas emissions, primarily from buildings and transportation. You need to make sure that there is enough money to do this, leaving no one behind for lack of funds. The recent Bay Area Air Quality Management District vote to require that end-of-use gas-fueled water and space heaters be replaced with electric ones underscores the need to help low-income communities comply with the coming rule changes.

The IPCC also stresses the need for immediate action on all fronts. The federal and state governments have taken serious action on climate in recent years, but this by no means absolves San Francisco from doing the same. In fact, city action and funding are indispensable to meeting national and global climate goals. Sitting it out is simply not an option.

Please find a way to include a climate bond on the ballot in 2024. To quote climate scientist Katharine Hayhoe: "Climate change stands between us and a better future. Many of the solutions are already at hand. At this point, the only question is: what are we waiting for?"

We want a chance to vote for a better future. Please give San Francisco something to be really proud of for Earth Month. Thank you.

I am outraged that the current schedule for city bonds does not have bonds for mitigating the climate crisis. There is no substitute for action to reduce greenhouse gas emissions, especially in the two most critical sectors of buildings and transportation.

For years we have been hearing Greta Thunberg and hundreds of thousands of other youth saying things like “we want you to act like your house is on fire. Because it is.” We listen, and nod, and say things like “yes, but you have to realize how many other urgent matters there are.” But things are only going to get worse, and unless we take action to mitigate the climate crisis now, they are going to get much worse much faster. To give one example: this spring we saw weather so violent that interstate commerce was delayed. What will it do to San Francisco’s economy when such weather becomes routine?

I am writing to implore the Budget and Appropriations Committee to include Climate Bonds in the 10 year bond schedule.

Despite the Board of Supervisors having declared a “Climate Emergency” 4 years ago, the City has taken very little of the “immediate and accelerated action to address the climate crisis and limit global warming to 1.5 degrees Celsius” that was called for in the emergency declaration.

Although there have been meetings and plans and goals, many of which are described in the Climate Action Plan (CAP), there have been woefully few actual actions in the four years since the declaration – and almost no funding. I have read that the Mayor’s budget did not call for **any** funding for the CAP in this year’s budget, and that it has been a struggle to get the Board of Supervisors to request even minimal funding as well.

There are countless actions this City can take to mitigate climate change, for example: planting trees; installing EV chargers; transitioning city vehicles to EV’s; enlisting schools, civic organizations, community groups, etc, in educational and grass roots actions to increase vegetation and decrease emissions; enact an ordinance banning idling vehicle motors; the list is endless.

But these actions require funding, and given the Mayor’s and Board of Supervisors’ inattention to those funding needs, we must have the ability to issue climate bonds to fund them. The citizens of San Francisco want to mitigate climate change. We want our City to help us do more, and I am certain we would pass climate bonds if they were allowed on the ballot.

Please include climate bonds in the 10 year bond schedule, beginning with next year’s bonds!



Honorable Supervisors:

Funding the city's Climate Action Plan developed by SFEnvironment is not just one among many important bond-funding considerations. It is the #1 priority. It's a necessity.

All the other needs of the city – as worthy as they all are – are meaningless in the face of the climate crisis that's already unfolding. If we don't act now to fully fund the Climate Action Plan, twenty years from now, this city will be struggling to survive.

We need to achieve net-zero GHG emissions as soon as possible. San Francisco has put ambitious goals in place, but they are not ambitious enough and we are not on track to achieve them.

Last year, for example, Supervisor Melgar revealed that 2017 legislation mandating that key city departments electrify their fleets by the end of 2022 had largely been ignored. 14% fleet electrification was the best that any department accomplished.

In comparison, the GHG emissions from the hundreds of MUNI buses still burning so called 'renewable diesel' are even more critical. All the emissions are critical – from buses, from cars and trucks, from buildings, from construction, from unfiltered waste management.

The cautious budgeting approach presented last Wednesday (4/19) by the Office of Resilience and Capital Planning won't cut it. Climate is not just 'one problem among many', as Director Brian Strong implied. When it comes to bond measures, funding the CAP must take precedence.

To do its part, San Francisco must electrify its buildings, thereby eliminating its use of natural gas – SF's biggest single source of climate emissions. This requires the retrofitting of over 200,000 buildings, a huge task, ultimately costing several billion dollars.

We must begin immediately. The benefits will not just be for the climate. Electrifying those buildings will require thousands of workers for years to come. These will be rewarding, good-paying jobs for San Franciscans.

Please vote to put a climate bond measure on the November 2024 ballot.

And, most recently, there has been a so-called drinking water AWSS which relies on Lake Merced which is not drinking water.

AWSS was transferred from the Fire Department to the SFPUC by then - Mayor Gavin

Newsom.

This was to balance the City's budget.

DCA John Roddy handled the City Attorney aspects of the transfer.

I'm opposed to ESER bond funds going to the SFPUC to fund its misguided policies.

A solution would be to transfer AWSS engineering to DPW and AWSS administration to a new department under the City Administrator.

I'm writing (again) to strongly encourage the Board of Supervisors to use \$140 million of the \$150 million more in bond capacity that was recently discovered by adding it on to the Affordable Housing & Shelter Bond scheduled for March 2024, making the grand total bond offering \$340 million. Then, use the \$140 million of "found" bond capacity to rehab existing affordable housing units by putting in clean, efficient electric heat pumps and taking out the old natural gas appliances. This will be an important step forward for San Francisco to reduce its carbon emissions and to provide low-income tenants with a healthier, cheaper energy source.
