# Under the proposed amendment, Richmond Area Multi-Services, Inc (RAMS) would continue to provide:

- Adult Outpatient Services Clinic: Outpatient mental health services for adults and older adults. Services include: ongoing individual, counseling, psychiatric services, case management services, and as-needed crisis intervention and meetings with patients' family and friends.
- Broderick Street Residential: Residential and mental health services to stabilize adults with serious and persistent mental illness, including clients with co-occurring MH/SUD w/ or w/o physical health needs.
- Asian & Pacific Islander Mental Health Collaborative (APIMHC): Lead agency in collaborative of non-profits focused on Filipino, Samoan, and Southeast Asian communities. Services include outreach and engagement, screening and assessment, wellness promotion activities, and linkages to services.
- MegaBlack Adult Outpatient Services Expansion: Outpatient mental health services for birthing people.

### RAMS Contracted Services within BHS System of Care

 RAMS contract is within the Adult and Older Adult System of Care (DPH-BHS)

#### Adult Outpatient Services Clinic:

- Outpatient mental health services (e.g., case management, therapy, psychiatry, medication management)
- Special focus on serving Asian and Pacific Islander American and Russian-Speaking communities
- Serves 600 unduplicated clients per year

#### Broderick Street Adult Residential:

- Serves adults with serious and persistent mental illness (co-occurring MH/SUD with or without physical health needs)
- Long-term care facility, licensed as an Adult Residential Facility (board and care for individuals <60 years old) for 33 beds.</li>

### RAMS Contracted Services within BHS System of Care

## <u>Asian & Pacific Islander Mental Health</u> <u>Collaborative (APIMHC)</u>

- All ages and gender groups in the South of Market, Tenderloin, Bayview-Hunters Point,
   Potrero Hill, and Visitacion Valley neighborhoods
- Outreach and engagement, screening and assessment, wellness promotion activities, and service linkages for Filipino, Samoan, and Southeast Asian (Cambodian, Laotian, and Vietnamese) communities.
- 8,796 individuals contacted

## MegaBlack Adult Outpatient Services Expansion

- Pilot program expanding outpatient mental health services for birthing people during pregnancy, perinatal and postpartum period of their maternal health
- MegaBlack add back funding is a one-time allocation to pilot providing services to birthing people needing mental health support.
