3	Resolution approving the settlement of the unlitigated claim filed by KHP III SF Sutter		
4	LLC against the City and County of San Francisco for \$3,750,000; the claim was filed on		
5	January 10, 2023; the claim involves allegations of property damage to the Kimpton		
6	Buchanan Hotel caused by shelter-in-place (SIP) hotel guests during the COVID-19

8	mutual full and final release, with each party to bear their own costs.
