3 **Ordinance authorizing settlement of the lawsuit filed by Alexis Krup against the City**
4 **and County of San Francisco for \$3,325,000; the lawsuit was filed on October 9, 2020,**
5 **in San Francisco Superior Court, Case No. CGC-20-587218; entitled Alexis Krup v. City**
6 **and County of San Francisco, et al.; the lawsuit involves alleged personal injuries from**
7 **a vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Alexis Krup v. City and County of San
12 Francisco, et al., San Francisco Superior Court, Case No. CGC-20-587218 by the payment of
13 \$3,325,000. The lawsuit involves alleged personal injuries from a vehicle collision.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 October 9, 2020, and the following parties were named in the lawsuit: plaintiff Alexis Krup;
16 defendants City and County of San Francisco and Bruce Pennington.
