[Condemning Texas State Senate Bill No. 147 (Kolkhorst) - Banning the Purchase of Real Property by Immigrants]

Resolution condemning Texas State Senate Bill No. 147 that prohibits immigrants from owning Texas real estate.

WHEREAS, Texas State Senator Lois Kolkhorst introduced State Senate Bill 147 (SB 147) which as currently proposed, will prohibit, among other things, citizens of China, Iran, North Korea, or Russia from owning real property located in the State of Texas; and

WHEREAS, SB 147, perhaps disguised as necessary for national security, is a racist proposal that serves no legitimate state purpose; and

WHEREAS, SB 147 is at its core an Alien Land Law, which was deeply rooted in our dark and ugly history of targeting and banning Asian Americans from owning real estate in Washington, Oregon, and California, serving only to institutionalize racism and discriminatory practices; and

WHEREAS, We have since then learned from this racist past and overturned Alien Land Laws, including in California, when in 1952 the California Supreme Court ruled that California's 1920 Alien Land Law violated the equal protection clause of the 14th Amendment; and

WHEREAS, Alien Land Laws and other exclusionary policies have a harmful and dehumanizing effect on immigrants, their families, and their communities and the repercussions are still felt today; and

WHEREAS, Two similar Texas State Senate Bills 552 and 711 have been introduced, and have the same effects of prohibiting "aliens and citizens" of China, Iran, North Korea, and Russia from entering into a contract for agricultural land and acquiring title to real property; and

state, making investments in their communities, and pursuing the American Dream; and 2 WHEREAS, SB 147 will create unnecessary and undue burdens and expenses on 3 financial institutions, title insurance companies, professionals, and the real estate industry; 4 5 and WHEREAS, Alien Land Laws like SB 147 violate the Equal Protection Clause of the 6 7 United States Constitution and the Civil Rights Act; and WHEREAS, there is broad community opposition to SB 147 including the Asian 8 9 American Bar Association of Houston (AABA Houston), the Austin Asian American Bar 10 Association (Austin AABA), and the Dallas Asian American Bar Association (DAABA), and the National Asian Pacific American Bar Association (NAPABA); now, therefore, be it 11
