

3	Resolution declaring May 18, 2023, as Asian American and Pacific Islander Against
4	Bullying and Hate Day in the City and County of San Francisco.
5	
6	WHEREAS, May 18 is the birthday of Vincent Chin, whose brutal murder in Detroit in
7	1982 sparked a national Asian American activist movement that continues to this day; and
8	WHEREAS, In 2019, in recognition of Vincent Chin's birthday and Asian Pacific American
9	Heritage Month, Act to Change spearheaded the first National Asian American and Pacific
10	Islander (AAPI) Day Against Bullying and Hate as part of its mission to end bullying among AAPI
11	youth; and
12	WHEREAS, We have seen a staggering rise in bullying, discrimination, and hate
13	crimes against the AAPI community since the start of the COVID-19 pandemic; and
14	WHEREAS, One in five students reports being bullied during the school year and 80% of
15	Asian American youth report being bullied, online or in school; and
16	WHEREAS, Certain AAPI populations, including South Asian, Muslim, Sikh, Micronesian,
17	LGBTQ, immigrant, and limited English proficient youth are more likely to be the targets of
18	bullying; and
19	WHEREAS, Between March 19, 2020, and March 31, 2022, two out of three of nearly
20	11,500 incidents involved harassment, such as verbal or written hate speech or inappropriate
21	gestures; and
22	WHEREAS, May is also Mental Health Awareness Month, and the AAPI community has
23	the lowest rate of any racial or ethnic group seeking help, often due to lack of awareness, or
24	linguistic and cultural barriers; now, therefore, be it
