San Francisco Charter Section 4.137

- ▶ Supervisor Shamann Walton proposed, and voters passed San Francisco Charter amendment Section 4.137 in the November 2020 General Election.
- ▶ Charter Section 4.137, Sheriff's Department Oversight, authorized the creation of the Sheriff's Department Oversight Board (SDOB) and the Office of Inspector General (OIG), and requires the SDOB to prepare and present an annual report summarizing the board's work and progress.
- ▶ The SDOB is currently working on hiring an Inspector General (IG) before the end of this calendar year. The IG will create the OIG. Therefore, this new department does not exist yet.

Section 4.137 Authorizes the SDOB to:

- ▶ Appoint the Inspector General (IG) to create and lead the Office of Inspector General (OIG).
- ▶ Evaluate the work of the OIG and the IG's performance.
- ▶ Compile, evaluate, and recommend law enforcement custodial and patrol best practices.
- ▶ Conduct community outreach and receive community input on Sheriff operations and jail conditions.
- ▶ Hold hearings, issue subpoenas to witnesses to appear and to produce evidence, administer oaths, and take testimony.

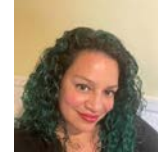

SDOB Held Four Meetings in 2022

- Recruiting and hiring resources and pathways.
- Sheriff's staffing, operations, and custody statistics.
- Leadership experiences with starting up a new oversight agency, challenges, best practices, and suggestions.
- DPA's support for building the new department and continuing the work on investigations.
- The budget necessary for the new department.

And invite public input.



SDOB Progress to Date

All board members completed 20 hours of charter-mandated training presented by subject matter experts on custodial law enforcement, constitutional policing, and SFSD policies and procedures.



The SDOB established a schedule to recruit, screen, interview, hire, and install the Inspector General.



The SDOB collaborated with DHR to create a comprehensive job description which is now posted, and candidates are starting to apply.



The Department of Police Accountability (DPA) continues to investigate allegations of sheriff deputy misconduct pursuant to its 2019 and 2020 agreements with the Sheriff.

- ▶ Reduce General Fund Support by 8% in FY 2023-2025
 - ▶ SDA plans to space out hiring and use salary savings to meet the 8% reduction


