8	Ambassador Program is a community safety and neighborhood program that engages,
9	informs, and assists community members in San Francisco; and
10	WHEREAS, Community Ambassadors also provide a visible, non-law enforcement
11	safety presence in several neighborhoods; and
12	WHEREAS, Community Ambassadors also provide safety escorts, report emergencies
13	and hazards, conduct wellness checks and link community members to available social
14	services; and
15	WHEREAS, The Office of Civic Engagement and Immigrant Affairs uses the City's
16	Corporate Seal for the vests and jackets worn by its members of Community Ambassadors
17	program; and
18	WHEREAS, The City's Corporate seal is located on both the upper-front left and back
19	of the vests and jackets; and
20	WHEREAS, The use of the City's Corporate Seal for the purpose of such jackets was
21	not authorized by the Clerk of the Board of Supervisors; and
22	WHEREAS, Nor did the Board of Supervisors approve the use of the City's Corporate
23	Seal for the jackets; and
24	WHEREAS, San Francisco Administrative Code, Section 1.6(c), empowers the Clerk of
25	the Board of Supervisors with custody of the City's Corporate Seal to be used for official

1	business of the City and County of San Francisco, and for matters approved by the Board of
2	Supervisors by Resolution; now, therefore, be it
3	RESOLVED, That the Board of Supervisors of the City and County of San Francisco
4	retroactively authorizes the use of the City's Corporate Seal by the Office of Civic
5	Engagement and Immigrant Affairs for the purpose of jackets for Community Ambassadors;

7	FURTHER RESOLVED, That the use of the City's Corporate Seal shall not be used
8	beyond the designations or purposes approved by this Resolution.
