[Asian American and Pacific Islander Against Bullying and Hate Day - May 18, 2023]

WHEREAS, May 18 is the birthday of Vincent Chin, whose brutal murder in Detroit in 1982 sparked a national Asian American activist movement that continues to this day; and

WHEREAS, In 2019, in recognition of Vincent Chin's birthday and Asian Pacific American Heritage Month, Act to Change spearheaded the first National Asian American and Pacific Islander (AAPI) Day Against Bullying and Hate as part of its mission to end bullying among AAPI youth; and

WHEREAS, We have seen a staggering rise in bullying, discrimination, and hate crimes against the AAPI community since the start of the COVID-19 pandemic; and

WHEREAS, One in five students reports being bullied during the school year and 80% of Asian American youth report being bullied, online or in school; and

WHEREAS, Certain AAPI populations, including South Asian, Muslim, Sikh, Micronesian, LGBTQ, immigrant, and limited English proficient youth are more likely to be the targets of bullying; and

WHEREAS, Between March 19, 2020, and March 31, 2022, two out of three of nearly 11,500 incidents involved harassment, such as verbal or written hate speech or inappropriate gestures; and

WHEREAS, May is also Mental Health Awareness Month, and the AAPI community has the lowest rate of any racial or ethnic group seeking help, often due to lack of awareness, or linguistic and cultural barriers; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco declare May 18, 2023, as Asian American and Pacific Islander Against Bullying and Hate Day in the City and County of San Francisco.
