The panel discusses and scores the artists.  The highest scored artist, Machinic LLC (DBA Futureforms), is selected for recommendation to the Arts Commission.	
June 16, 2021	Visual Arts Committee	Project Manager Zoë Taleporos presented the recommended artist team, Futureforms, and their proposal for the Potrero Gateway Park public art project. Ms. Taleporos stated that the Arts Commission will enter into a MOU with Public Works for the development of a public artwork at this site. The budget for the artwork is \$217,000 and the artwork will not be accessioned into the City's art collection, but will become property of Caltrans. The motions were unanimously approved. 		Project Manager Zoe Taleporos presented the Design Development

		The original proposed work consisted of galvanized steel plant wells,	
		which would allow plant roots to grow into the ground. The sculptures	
		were to be bolted to the retaining wall and soil, plantings, irrigation,	
		and lighting were to be provided by Public Works. However, new

		to the retaining walls didn't accommodate the original design concept	
		without violating ADA code.	
		The revised designs are freestanding sculptures that retain the same	
		look and feel as the original planters. The sculptures will range in height	
		from 6 ft. 9 in. to 9 ft. 1 in. and widths from 3 ft. 6 in. to 7 ft. 1 in. For	
		the San Bruno side, the works will sit atop cast concrete plinths. For the	
		Vermont St. side, Public Works will integrate the artwork foundation	
		into the middle retaining wall. The motion was unanimously approved.

June 15, 2022	Visual Arts Committee	Project Manager Aleta Lee gave a brief description of the Potrero Gateway project and introduced the artist team FutureForms to share the revised artwork design. The artists shared changes to the project site, including a different color palette, smaller sidewalk dimensions, and shifting wall configurations and fences, which required the initial artwork proposal to evolve. The artwork now consists of four sculptures grouped in two pairs, on the east side of the overpass and one on the west side. The sculptures will be placed within the planters on plinths. Each sculpture is unique with its own scale and configuration. The sculptures are intended to be heavier and more rounded at the base and lighter at the top. The spheres are all different finishes of stainless steel or will be painted with metallic Tnemec paint color.	
		The commissioners asked about the maintenance and climb ability of the sculptures. The artists shared that the materials should be easily cleaned, especially the lower sections, but are also being designed to be taken apart for easier deep cleaning in the future. Additionally, each sculpture can withstand a few hundred pounds of weight on them if a person were to climb the artwork. There was no public comment, and the motion was unanimously approved.
