4 **LLC against the City and County of San Francisco for \$463,593; the lawsuit was filed on**
5 **December 12, 2022, in San Francisco Superior Court, Case No. CGC-22-603406; entitled**
6 **New Cingular Wireless PCS LLC. v. City and County of San Francisco et al.; the lawsuit**
7 **involves a claim for refund of penalties and interest related to the access line tax for**
8 **tax periods February 1, 2021, through and including August 31, 2021.**

10 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
13 authorizes the City Attorney to settle the action entitled *New Cingular Wireless PCS LLC v.*
14 *City and County of San Francisco et al.*, San Francisco Superior Court, Case No.
15 CGC-22-603406 by the payment of \$463,593. The lawsuit involves a claim for refund of
16 penalties and interest related to the access line tax for tax periods February 1, 2021, through
17 and including August 31, 2021.

19 Section 2. The above-named action was filed in San Francisco Superior Court on
