9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Xavier Pittman v. City and County of
12 San Francisco, et al., United States District Court, Northern District of California, Case No. 22-
13 cv-02412-LB by the payment of \$195,000. The lawsuit involves the lawsuit involves an officer
14 involved shooting.
