\$2.2 Million Settlement of Lawsuit: 11 *Jane and John Does*, 2019 Sexual Abuse and Patient Abuse Scandal at Laguna Honda Hospital, July 2019 — Prologue of Costs to Come

Dear Board President Peskin, and Members of the Board of Supervisors,

I hope the Board of Supervisors understand that the \$2.23 million lawsuit settlement in Superior Court Case Number CGC-21-592296 against Laguna Honda Hospital is only the first of several lawsuit settlements that are in the pipeline.

Indeed, the table below shows that costs associated with the mismanagement of Laguna Honda before the patient sexual abuse scandal at LHH erupted in 2019 and other costs have already cost the City close to \$5 million due entirely to LHH's mismanagement.

As the table above shows, there are at least three other named lawsuits in just the sexual abuse and patient abuse 2019 scandal category remaining, including the *Alfred Coutts* case (CGC-20-584459) that is now scheduled for Jury Trial on October 2, 2023, the *Tommy Johnson et al.* case (CPF-20-517064) with another *Case Management Conference* scheduled for June 29, and the *Delland Felder* case (CGC-22-599447).

The latter two cases are class action lawsuits representing multiple Plaintiffs, just as the "*cluster*" case you are settling today involves a "*cluster*" for 11 of the initially 17 fictitiously named "*Doe*" Plaintiffs in Case # CGC-21-592296.

It is thought additional Plaintiff's who opted out of other 2019 patient sexual abuse and elder abuse Class Action or "*cluster*" lawsuits — potentially including six of the remaining named "*Does*" in Case # CGC-21-592296 — may be pursuing their own individual lawsuits not listed in the chart above.

In addition, at least one Superior Court "cluster" lawsuit involving wrongful deaths of LHH patients involuntarily discharged from LHH in the summer of 2022 in the initial "LHH Closure Plan" has been filed — Sanchez, Lieu, Pham v. CCSF LHH (CGC-23-606373). It is thought another "cluster" lawsuit involving family members or Guardians ad Litem of additional Decedents may be in progress.

Although the chart above shows almost \$5 million expenses to date related to lawsuit settlements, fines, and civil monetary penalties and expenses the mismanagement of LHH has caused to date, it is though that total will likely rise to a minimum of \$10 million relatively soon.

Unfortunately, there has been little accountability in the way of progressive discipline against Laguna Honda Hospital staff and managers who allowed these deplorable conditions to have festered and spread within the facility.

The Board or Supervisors should look into why LHH's former CEO, Mivic Hirose, was allowed to remain a City employee in the San Francisco Department of Public Health after the elder abuse and sexual abuse scandal between 2016 and 2019 erupted — since it was under her watch when these substandard care practices worsened, but she failed to establish a "culture of safety" at LHH for the hospital's vulnerable patients. That scandal led directly to LHH's decertification in April 2022.

Along with others, Hirose needs to be held accountable for contributing, in part, to LHH's decertification.

After all, this \$5 million estimate needs to be *added to* the approximately \$59.6 million in known expenses to date as a result of LHH's decertification and subsequent recertification-related expenses that continue to grow.

The Board of Supervisors need to demand accountability for the nearly \$64.5 million in costs borne by taxpayers to date.
