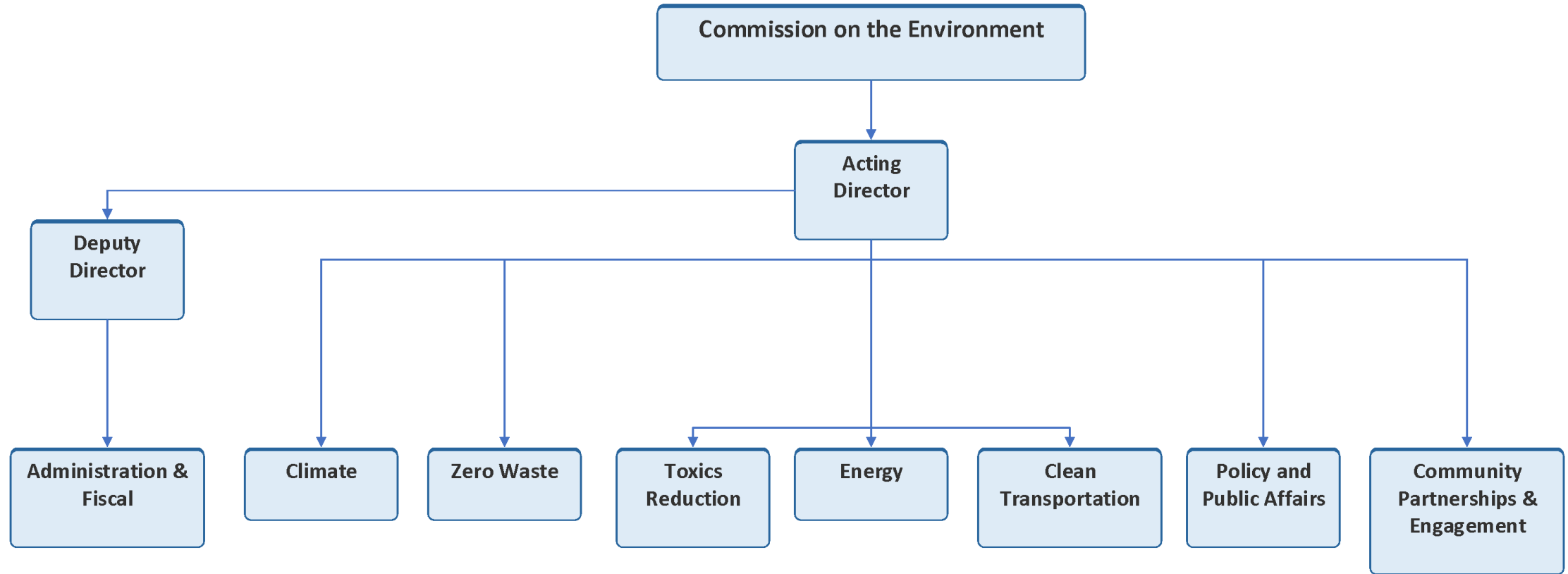

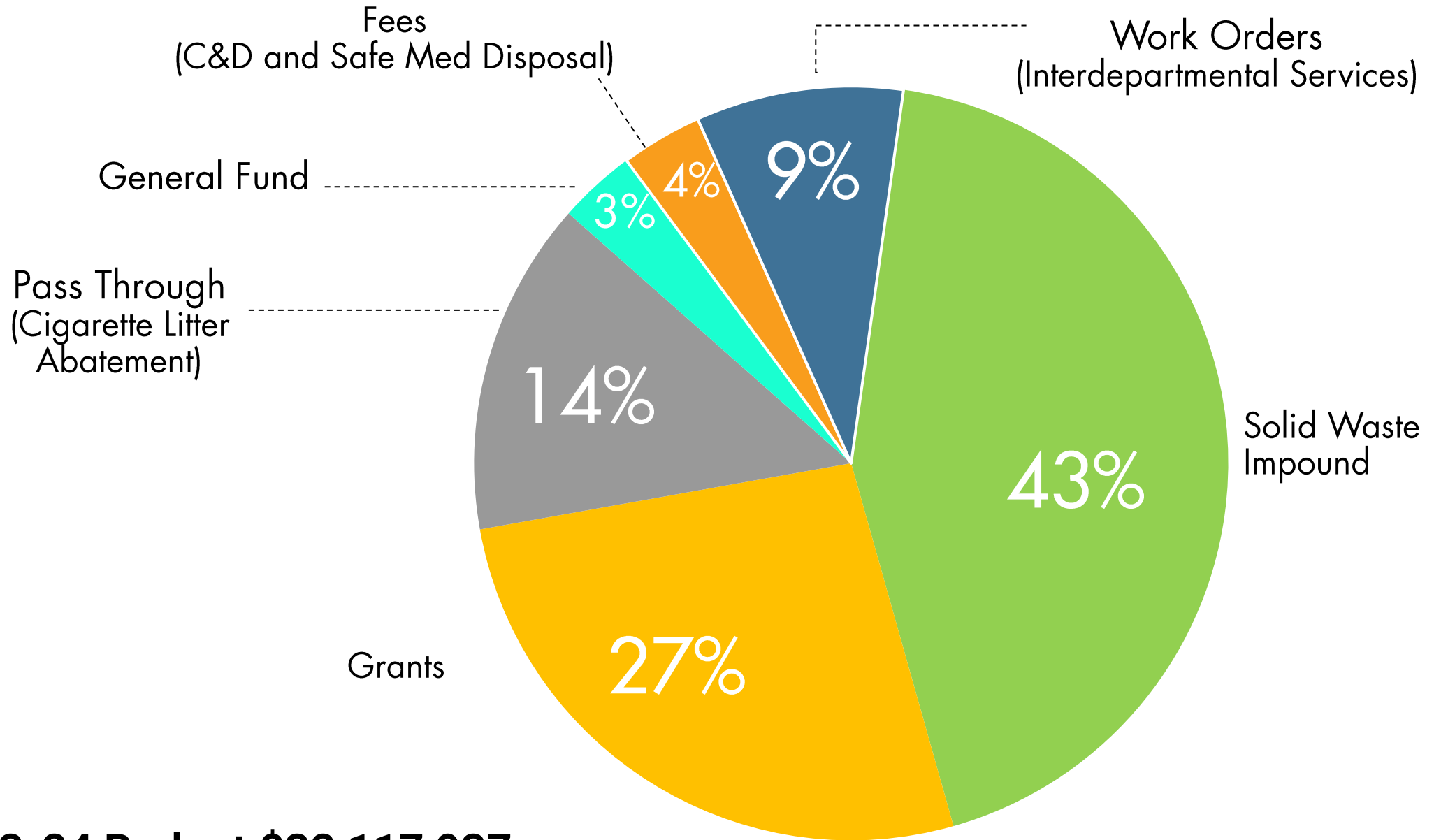

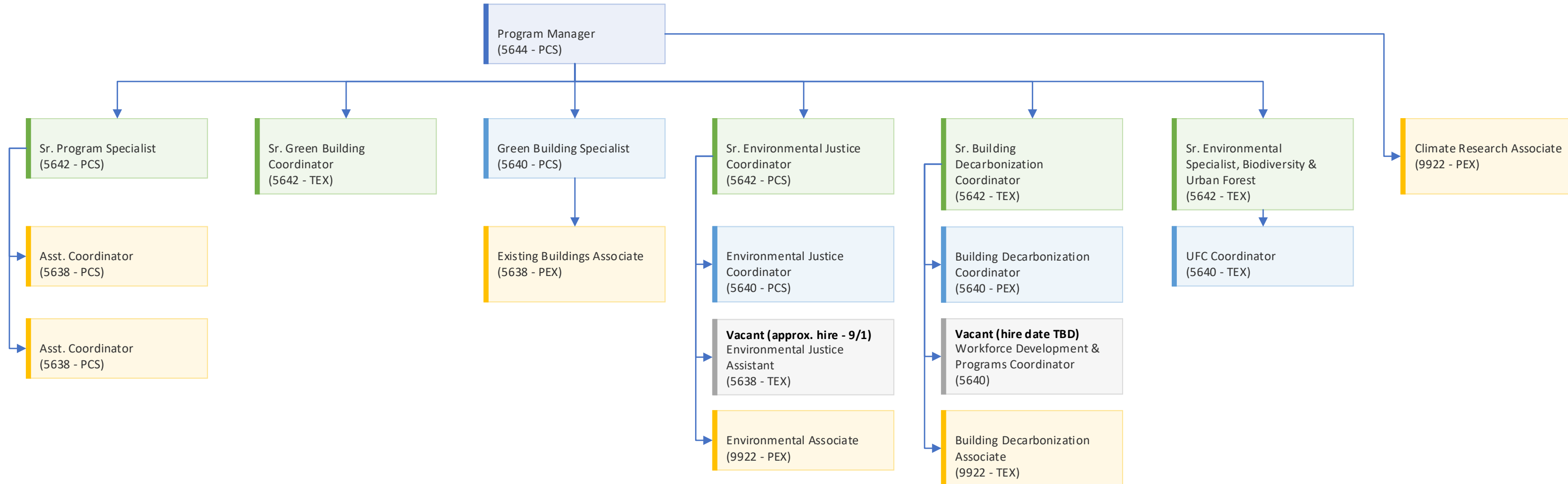
SF Environment Department High Level Organizational Chart



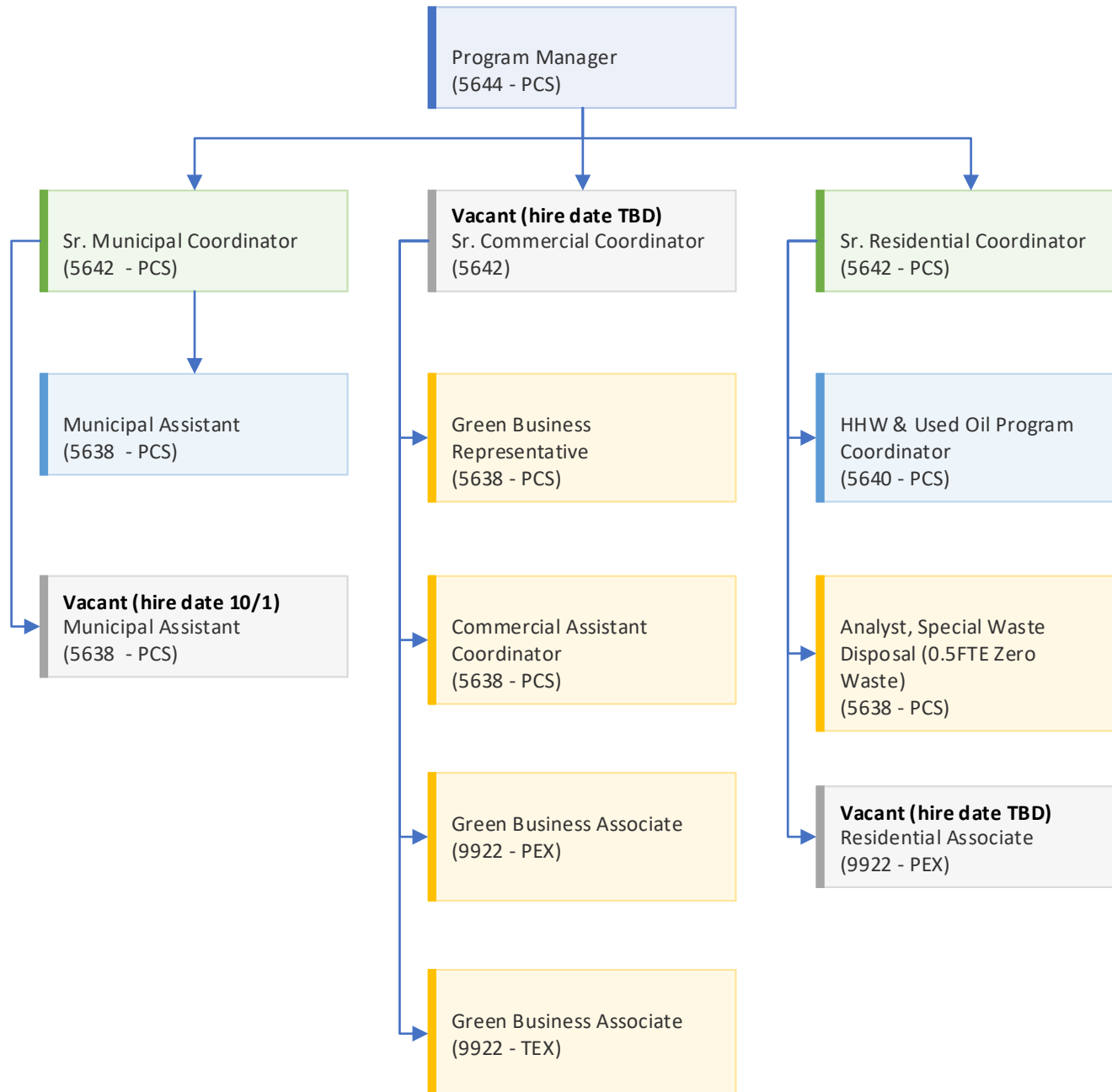
SF Environment Department Zero Waste Program



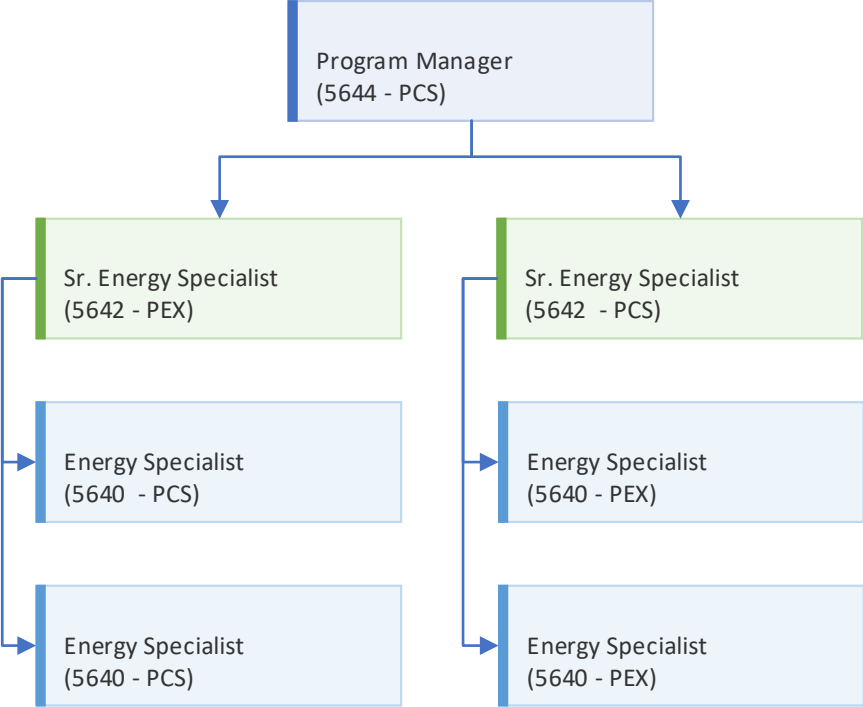
SF Environment Department Climate Program



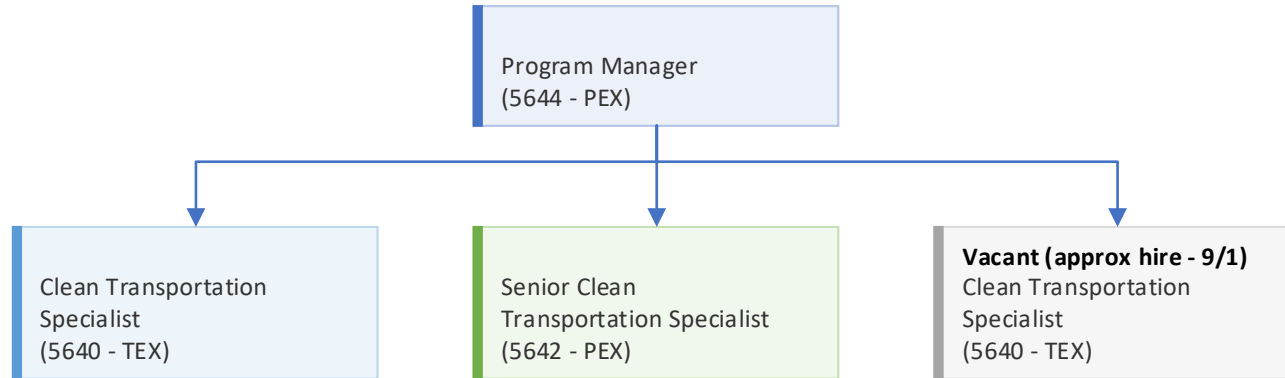
SF Environment Department Toxics Reduction Program



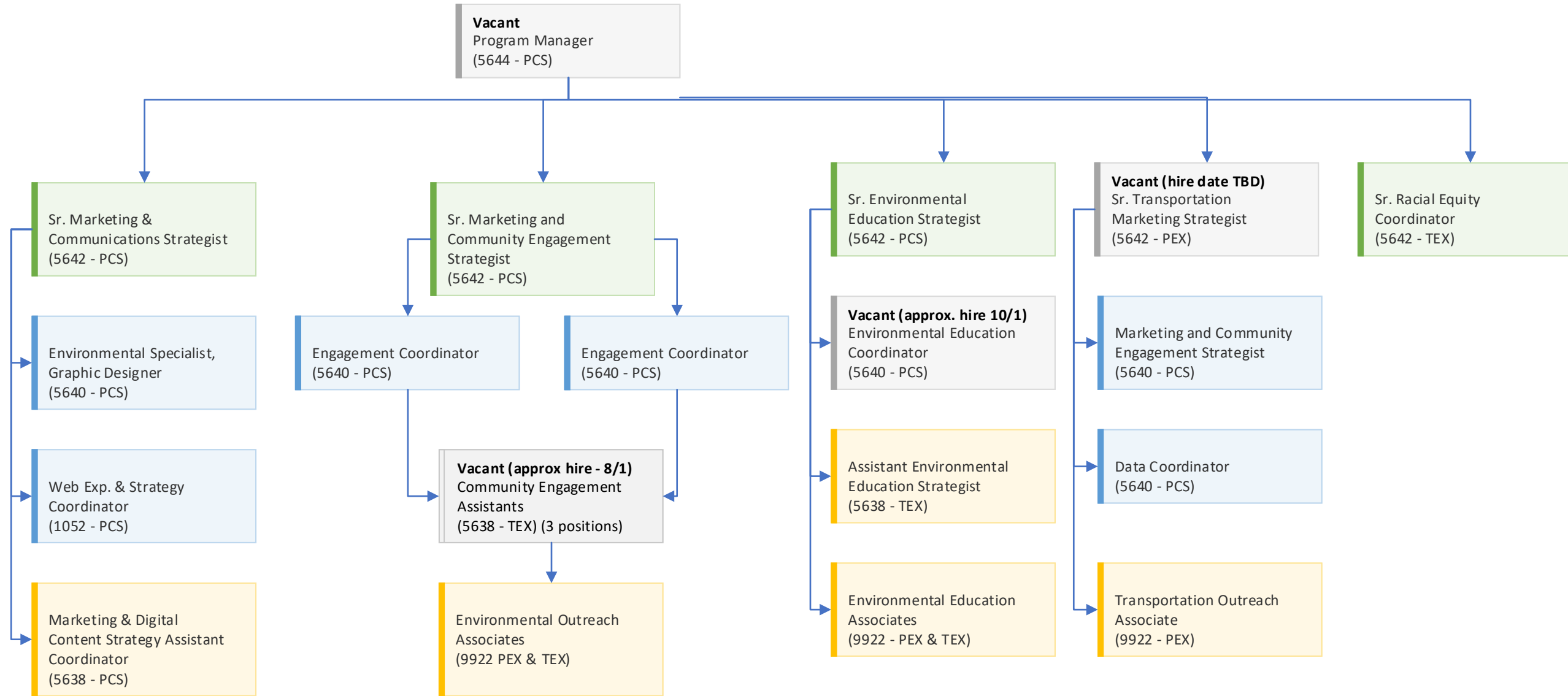

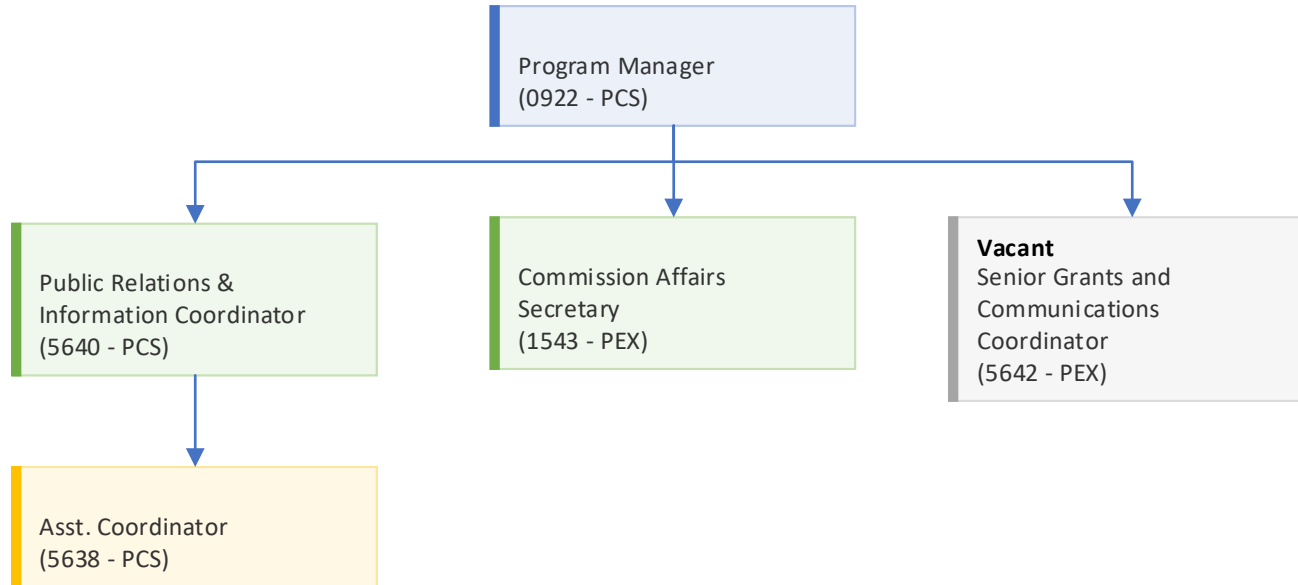

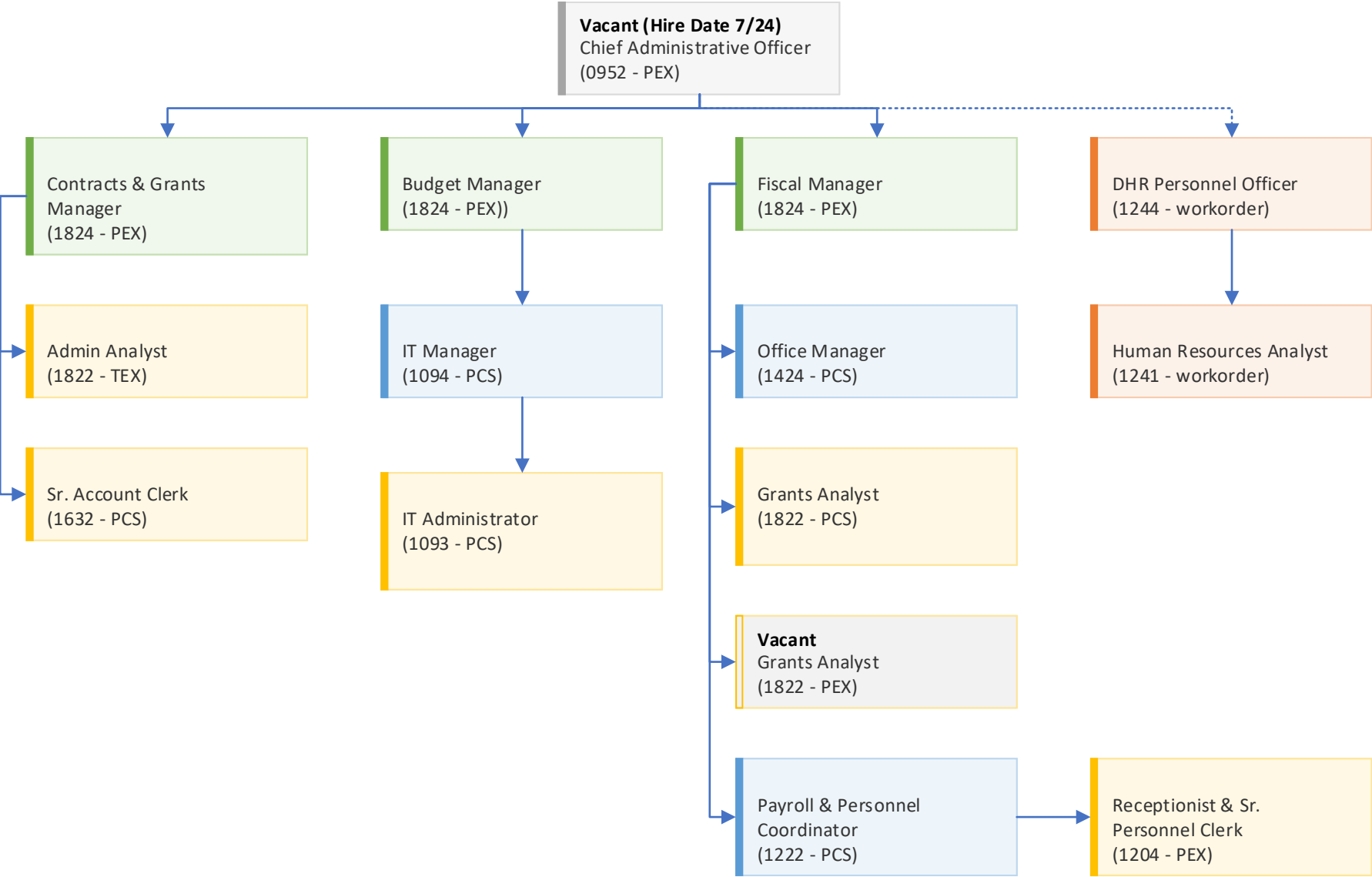
