3 **Resolution approving the settlement of the unlitigated claims filed by The Wiseman**
4 **Group Interior Design, Inc. against the City and County of San Francisco for \$40,000;**
5 **the claims were filed on January 30, 2023, and March 8, 2023; the claims involve a**
6 **refund of gross receipts tax; an additional material term of the settlement is that The**
7 **Wiseman Group Interior Design, Inc. shall take certain filing positions with respect to**
8 **its gross receipts taxes for tax year 2023 and subsequent tax years.**

10 WHEREAS, The Wiseman Group Interior Design, Inc. filed claims on January 30,
11 2023, and March 8, 2023, against the City and County of San Francisco; and

12 WHEREAS, The claims involve a refund of gross receipts tax; and

13 WHEREAS, The Office of the Treasurer and Tax Collector has recommended
14 settlement of the claims by payment of \$40,000 and agreement that The Wiseman Group
15 Interior Design, Inc. will take certain filing positions with respect to its gross receipts taxes for
16 tax year 2023 and subsequent tax years; now, therefore, be it

17 RESOLVED, That pursuant to Administrative Code, Section 10.22, the Board of
18 Supervisors hereby authorizes the City Attorney to settle and compromise the claims by
19 payment of \$40,000 and agreement that The Wiseman Group Interior Design, Inc. will take
20 certain filing positions with respect to its gross receipts taxes for tax year 2023 and
21 subsequent tax years.
