Be it ordained by the People of the City and County of San Francisco:

Section 1. Chapter 21 of the Administrative Code is hereby amended by revising Sections 21.02 and 21.8, to read as follows:

SEC. 21.02. DEFINITIONS.

As used in this Chapter <u>21</u>, the following words shall have the following respective meanings:

—"Technology Store" shall mean the City wide, multiple award contract for the procurement of certain Commodities and Services awarded pursuant to the "Request for Proposal for Computer Hardware, Software, Peripherals and Appropriate Network, Consulting, Maintenance, Training and Support Services," and any successor contracts thereto.

"Technology Marketplace" shall mean the citywide contracts and lists of prequalified contractors, including any successor contracts and prequalified lists, administered by the Purchaser

for the procurement of technology Commodities and Services, including but not limited to hardware, software, peripherals, technology maintenance, training, and support.

SEC. 21.8. MULTIPLE AWARD CONTRACTS.

(b) **Technology** <u>Marketplace</u>Store Any department or other entity ordering

Commodities or Services through the Technology <u>MarketplaceStore shall may be required to pay</u>
an administrative fee <u>as determined by the Purchaser</u> of up to one and nine tenths percent (1.9%) of
the total purchase price of Commodities and Services purchased through the Technology
StoreMarketplace. Such administrative fee shall be used solely to pay the City's actual costs of
administering the Technology MarketplaceStore contracts for the benefit of City departments.

Section 2. Effective Date and Operative Date.

- (a) This ordinance shall become effective 30 days after enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the Mayor's veto of the ordinance.
 - (b) This ordinance shall become operative on July 1, 2023.
