[Police Code - Drawing of Firearms by Armed Guards]

**Ordinance amending the Police Code to prohibit armed guards from drawing or exhibiting firearms, other than a holster, to protect property.**

Section 1. Article 25 of the Police Code is hereby amended by revising Sections 1750.19 and 175.20, to read as follows:

**SEC. 1750.19. DRAWING OF FIREARMS.HANDGUNS.**

It shall be unlawful for any armed guard, while in any place in the City and County of San Francisco, to draw or exhibit other than in a holster any firearm handgun except in lawful response to an actual and specific threat to a person or persons. and/or property.

**SEC. 1750.20. PERMITTING DRAWING OF FIREARMS. HANDGUNS.**

It shall be unlawful for any person, corporation, partnership, or association which employs or utilizes armed guards to require, allow or permit any such guard, while in any place in the City and County of San Francisco, to draw or exhibit other than in a holster any firearm handgun except in lawful response to an actual and specific threat to a person or persons. and/or property. In any prosecution for violation of this Section 1750.20, proof that such person, corporation, partnership, or association did not, at the time a guard unlawfully drew or exhibited a firearm handgun, have a written rule prohibiting such acts, shall be prima facie

1 evidence that such person, corporation, partnership or association required, allowed or  
2 permitted such conduct.

3  
4 Section 3. Effective Date. This ordinance shall become effective 30 days after  
5 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
6 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
7 of Supervisors overrides the Mayor's veto of the ordinance.

8  
9 Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
10 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
11 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
12 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
13 additions, and Board amendment deletions in accordance with the "Note" that appears under  
14 the official title of the ordinance.

## **LEGISLATIVE DIGEST**

[Police Code - Drawing of Firearms by Armed Guards]

**Ordinance amending the Police Code to prohibit armed guards from drawing or exhibiting firearms, other than a holster, to protect property.**

### **Existing Law**

Currently, Article 25 prohibits any armed guard from drawing or exhibiting, other than in a holster, any handgun except in lawful response to an actual and specific threat to person and/or property. Article 25 also prohibits any person, corporation, partnership, or association which employs or utilizes armed guards to require, allow or permit any such guard, while in any place in the City and County of San Francisco, to draw or exhibit other than in a holster any handgun except in lawful response to an actual and specific threat to person and/or property.

### **Amendments to Current Law**

If passed, these amendments would delete all references to property and update all references from a handgun to a firearm.

Dear Board of Supervisors,

On behalf of the San Francisco Women's Political Committee (SFWPC), we are writing in strong support of Ordinance #230708, amending the Police Code to prohibit armed guards from drawing or exhibiting firearms, other than a holster, to protect property.

We ask you to support Ordinance #230708, as it can prevent future deaths from happening and it can be a step for local government, the San Francisco Police Department, and security companies to collaborate with the community to search for *new strategies* that deter and address the root causes of crime that do not involve high risk of death. Material things are replaceable, human lives are not.

Sadly, our city has a documented history of bias complaints against security guards, that the Board of Supervisors already tried to address in 2022<sup>1</sup>. Our Black and LGBTQ+ neighbors are disproportionately targeted. The death of Bank Brown was preventable, and we need to make sure to address this issue before we lose more San Franciscans. Prohibiting security guards from drawing firearms in the protection of property will ensure that we place the value of all lives above the property of businesses, especially multi-billion dollar ones.

The United Nations Principles on the Use of Force and Firearms by Law Enforcement Officials states that “*firearms should only be used by law enforcement in self-defense or against the imminent threat of death or serious injury.*”<sup>2</sup> Private security guards are not certified as law enforcement<sup>3</sup>, and should not be required by their employers to protect private property by putting themselves at high risk of injury or death to themselves, to the offender and to the public. The investigation of Banko Brown’s death revealed that the contracting company who employed the security guard had recently changed their policies to direct their employees to do “hands-on” recovery of the goods in stores: we can’t let private companies encourage violence and put in jeopardy the lives of the most vulnerable of us.

We urge you to pass Ordinance #230708, because our community needs healing in the wake of the death of Banko Brown. This Ordinance puts first our common value of protecting human life above private profits, while giving us the opportunity to re-think the meaning of public safety and find *new ways* to tackle crime and its roots in our community.
