4 **and County of San Francisco for \$465,000; the lawsuit was filed on September 7, 2021,**
5 **in San Francisco Superior Court, Case No. CGC-21-595136; entitled Wayne Kha v.**
6 **Johnathon Ng, et al.; the lawsuit involves an alleged personal injury arising from an**
7 **accident involving a police car.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Wayne Kha v. Johnathon Ng, et al.,
12 San Francisco Superior Court, Case No. CGC-21-595136 by the payment of \$465,000. The
13 lawsuit involves an alleged personal injury arising from an accident involving a police car.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 September 7, 2021, and the following parties were named in the lawsuit: Wayne Kha,
16 plaintiff, Jonhathon Ng #282 and City and County of San Francisco, defendants.
