16	Section 1.
17	(a) Environmental Findings. The Planning Department has determined that the
18	actions contemplated in this ordinance comply with the California Environmental Quality Act
19	(California Public Resources Code Sections 21000 et seq.). Said determination is on file with
20	the Clerk of the Board of Supervisors in File No. 230767 and is incorporated herein by
21	reference. The Board affirms this determination
22	
23	
24	
25	(b) General Findings.

- (1) The two areas that are the subject of this ordinance are located at the northeast corner of Taraval Street and 46th Avenue, generally in front of 3600 through 3608 Taraval Street ("Taraval Hybrid Spaces").
- (2) During the COVID-19 emergency, one business associated with 3608 Taraval Street installed seating for patrons on a portion of the Taraval Hybrid Spaces as a shared space in accordance with Public Works Code Article 5.2 (Sections 176, et seq.), applicable Public Works Orders, and Permit No. 20TC-01181.
- (3) The area occupied by the Taraval Hybrid Spaces was constructed by the San Francisco Municipal Transportation Authority ("SFMTA"), through the Public Works Department, as part of the Taraval Streetscape Improvement Project ("Streetscape Project") in or around 2015. The Streetscape Project spanned the two westernmost blocks of Taraval Street and included public art, landscaping, roadway improvements, and sidewalk improvements.
- (4) The Streetscape Project included eight raised landscaped areas along the sidewalk that are separated from the driving and parking lanes by a curb. These areas are or resemble "bulb-outs," or, extensions of the sidewalk into the vehicular travelway, often used for traffic calming and street beautification. Seven of the bulb-outs are essentially landscaping enclosed by a curb and are situated a few inches from the sidewalk curb, separated by a gutter. The eighth bulb-out is different.
- (5) The eighth bulb-out which is the site of the Taraval Hybrid Spaces was designed and built as a community gathering and seating area, and includes a deck-like walking surface and decorative boulders designed for public seating. The ground surface portion of the Taraval Hybrid Spaces is flush with and immediately adjacent to the existing sidewalk and curb; this preserves an Americans with Disabilities Act ("ADA") compliant pedestrian path of travel width on the sidewalk. The Taraval Hybrid Spaces are functionally

- two seating areas next to each other on a single bulb-out, each seating area visually and
  physically separated from the other by landscaping. One of the Taraval Hybrid Spaces is
  generally in front of 3600 Taraval Street and the other is generally in front of 3606 3608
  Taraval Street. The Taraval Hybrid Spaces are enclosed by a continuous curb that separates
  the area from the travelway (the portion of the street for driving, transit, and parking).

  Decorative boulders and landscaping provide further visual and physical separation between
  - (6) SFMTA designated all eight bulb-outs, including the Taraval Hybrid Spaces, as "Traffic Islands (Curbside)" by Resolution No. 13-210, adopted on September 17, 2013. As built, the Taraval Hybrid Spaces unlike the other seven bulb-outs are physically and visually connected to the sidewalk, and were designed and built to function as seating areas.
  - (7) The sidewalks on Taraval Street were not formally widened to encompass the Taraval Hybrid Spaces or the other seven bulb-outs or "Traffic Islands (Curbside)." Accordingly, the Taraval Hybrid Spaces are not officially designated as "sidewalks," despite the fact that they visually appear to be and functionally operate as extensions of the sidewalk.
  - (8) The Shared Spaces Program authorizes designated City departments to authorize Shared Spaces only on the sidewalk, in the curbside lane (usually the parking lane), or on City-owned lots. The Taraval Hybrid Spaces are not officially on the sidewalk, although they visually appear to be sidewalk extensions; they are not clearly part of the curbside lane since they are not in a parking space and are separated from the travelway by a curb; and they are not on a City-owned lot.
  - (9) Notwithstanding the visual and functional similarity between the Taraval Hybrid Spaces and the sidewalk, the spaces are not located within the designated sidewalk area but rather are located in a portion of the right-of-way SFMTA described as "Traffic Islands (Curbside)." The Taraval Hybrid Spaces share few if any similarities with traditional

the travelway and the seating areas.

traffic islands; they were not designed as pedestrian refuges for crossing multi-lane roadways and they are immediately adjacent to the sidewalk, not located in the middle of the street.

- Shared Space occurring in a portion of the curbside lane of a City street." The Taraval Hybrid Spaces are outside of the sidewalk zone, but they are also outside of any "lane," as they are not within either a vehicular travel lane or parking lane. They were designed and designated to be separate from the travelway. A Curbside Shared Space also requires SFMTA approval of the curbside lane closure pursuant to Section 204 of Division II of the Transportation Code. No such "closure of the curbside lane" would be required or applicable to the Taraval Hybrid Spaces since they are not in a travel lane. Additionally, if the Taraval Hybrid Spaces were treated as Curbside Shared Spaces, they would need to be activated as more structurally substantial "parklets," including safety features designed to separate patrons from passing vehicles. Such a deployment would be redundant for the Taraval Hybrid Spaces which are already physically separated from the travelway by a curb, landscaping, and boulders, and include recent public streetscape improvements that could be obscured by parklet construction.
- (11) Consequently, the Taraval Hybrid Spaces are Shared Spaces that do not fall within the definitions or permitting scheme of the existing categories of Shared Spaces.
- (12) In recognition of the economic, health, safety, and recreational contributions that Shared Spaces have provided to commercial enterprises, neighborhood businesses, and City residents and visitors, the Board of Supervisors intends to allow the Taraval Hybrid Spaces to operate as viable extensions of the associated businesses in the same manner as similarly situated Sidewalk Spaces. To accomplish this objective, this ordinance waives specific provisions of the Administrative Code governing Shared Spaces that otherwise would be applicable to the Taraval Hybrid Spaces, conditioned on the Taraval

Hybrid Spaces undergoing minor physical modifications to make them compliant with
 applicable laws and similarly situated Shared Spaces.

Section 2. Waiver of Certain Administrative Code Provisions.

- (a) Notwithstanding Administrative Code Sections 94A.2, 94A.4, and 94A.5, the Taraval Spaces shall be treated as sidewalks for purposes of eligibility for a Shared Spaces permit. Administrative Code Sections 94A.2, 94A.4, and 94A.5 are hereby waived to the extent they would otherwise require an application for Taraval Hybrid Spaces to be processed as a Curbside Shared Space or denied for failure to meet the definition of a Sidewalk Shared Space.
- (b) In implementing these waivers, the Public Works Director shall process permits for the Taraval Hybrid Spaces in accordance with the other requirements of Administrative Code Sections 94A et seq., Public Works Code Sections 793 et seq., and Public Works regulations for Sidewalk Shared Spaces and shall ensure that the Taraval Hybrid Spaces are compliant with these laws and regulations. To the extent that implementation of these waivers presents a conflict with Public Works Code Sections 176 et seq. or Sections 793 et seq., the provisions of this ordinance shall prevail, and the Public Works Director is authorized to exercise discretion to amend or waive any design guidelines or other regulations in conflict with this ordinance; provided, however, that the Taraval Hybrid Spaces shall comply with all regulations, as may be modified by the Public Works Director, regarding public health and safety design features for Shared Spaces.

1	Section 3. Effective Date. This ordinance shall become effective 30 days after
2	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
3	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
4	of Supervisors overrides the Mayor's veto of the ordinance.

### **LEGISLATIVE DIGEST**

[Administrative Code - Treatment of Seating Area at Taraval Street and 46th Avenue as Sidewalk for Shared Spaces Program]

Ordinance waiving specified requirements in the Administrative Code to allow seating area designated as a curbside traffic island on Taraval Street at 46th Avenue to be defined as two sidewalk shared spaces, subject to certain requirements; and affirming the Planning Department's determination under the California Environmental Quality Act

### **Existing Law**

Restaurants, bars, and other establishments may place outdoor seating on public sidewalks and streets under the Shared Spaces Program, regulated by Chapter 94A of the Administrative Code. Tables and chairs placed on sidewalks must be brought indoors overnight. For curbside lanes, usually in parking spots, more substantial "parklets" may be constructed.

An existing business on Taraval Street at 46th Avenue has tables and chairs outside in an area that looks and functions more like a sidewalk than a curbside lane. The area is directly next to and flush with the sidewalk, and contains two seating areas and landscaping. This area was designated as a "Traffic Island (Curbside)" and therefore it is not clear whether it qualifies as either a sidewalk or curbside lane under the Shared Spaces program.

#### Amendments to Current Law

This ordinance would waive provisions of the Administrative Code to allow treatment of the seating areas on Taraval Street at 46th Avenue as "sidewalk" areas for purposes of the Shared Spaces Program. This would allow the nearby businesses to apply for Shared Spaces permits to place tables and chairs outside of their businesses. It would not allow the businesses to build "parklets."

### HIGHLIGHTS

- Taraval Streetscape project installed landscaped at intersections that resemble "bulb outs"
- The "bulb out" on Taraval at 46<sup>th</sup> was designed as a community gathering area with a deck-like walking surface
  - Classified as "Traffic Islands", not formally widening sidewalk
- Shared Spaces program does not authorize Public Works to permit it for sidewalk seating if not designated as sidewalk
- Ordinance waives Administrative code to allow 3600 Taraval "traffic island" to be eligible for a sidewalk Shared Spaces permit



### Permit Requirements



- A Sidewalk diverters at 90 degrees flush with building, at each end of Shared Space.

  Minimum Dimensions: 30 inches high, 12 inches wide, 24 inches long
- B Minimum 8-feet wide unimpeded path for pedestrians (where feasible)
- 4-feet clearance surrounding area beneath fire escape ladders
- Sidewalk Shared Spaces may not occupy the space adjacent to the curb, regardless of curb color. Exceptional circumstances may be considered if a hardship is present
- 5-feet clearance around a fire hydrant
- Provide at least one 30-inches x 48-inches clear space for wheelchair users at accessible tables. If a counter is provided, the accessible counter portion shall be 60"
- 3-feet clearance around Fire Department connections on buildings
- Bus stop zones must be maintained clear of furniture and structures. No furniture shall be placed within 10 feet of a bus shelter structure
- Ourb return and all curb ramps shall not be obstructed by Shared Space elements.
