3 **Ordinance authorizing settlement of the lawsuit filed by Cheri Pierce against the City**  
4 **and County of San Francisco for \$75,000; the lawsuit was filed on April 26, 2022, in San**  
5 **Francisco Superior Court, Case No. CGC-22-599362; entitled Cheri Pierce v. City and**  
6 **County of San Francisco, et al.; the lawsuit involves alleged personal injury arising out**  
7 **of fall on uneven sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Cheri Pierce v. City and County of San  
12 Francisco, et al., San Francisco Superior Court, Case No. CGC-22-599362 by the payment of  
13 \$75,000. The lawsuit involves alleged personal injury arising out of fall on uneven sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on April  
15 26, 2022, and the following parties were named in the lawsuit: Plaintiff: Cheri Pierce;  
16 Defendants/Cross-Defendant: City and County of San Francisco; Defendant/Cross-  
17 Complainant: San Francisco Unified School District.
