3 **Ordinance authorizing settlement of the lawsuit filed by Bi Jun Zhang against the City**  
4 **and County of San Francisco for \$35,000; the lawsuit was filed on May 17, 2022, in San**  
5 **Francisco Superior Court, Case No. CGC-22-599662; entitled Bi Jun Zhang v. City and**  
6 **County of San Francisco, et al.; the lawsuit involves a personal injury to Plaintiff from**  
7 **uneven pavement.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Bi Jun Zhang v. City and County of  
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-22-599662 by the  
13 payment of \$35,000. The lawsuit involves a personal injury to Plaintiff from uneven  
14 pavement.
