3 **Ordinance authorizing settlement of the lawsuit filed by Breon Johnson against the**
4 **City and County of San Francisco for \$100,000; the lawsuit was filed on September 26,**
5 **2022, in San Francisco Superior Court, Case No. CGC-22-601937; entitled Breon**
6 **Johnson v. The Regents of The University of California, et al.; the lawsuit involves**
7 **alleged medical negligence.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Breon Johnson v. The Regents of The
12 University of California, et al., San Francisco Superior Court, Case No. CGC-22-601937 by
13 the payment of \$100,000. The lawsuit involves alleged medical negligence.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 September 26, 2022, and the following parties were named in the lawsuit: Plaintiff Breon
16 Johnson; Defendants The Regents of The University of California; Dr. Amanda Sammann,
17 M.D.; Francis L. Valesterso, R.N.; Sharon Morse, R.N.; City and County of San Francisco.
