My name is Pam Tau Lee, a retired labor and environmental justice advocate, organizer and educator. I reside in District 1.

I am in support of item 21, Prioritizing and Protecting impacted Communities during APEC Economic Week. To me it is ironic that the Summit theme is "Creating a Resilient and Sustainable Future for All" when in actuality, since its inception, it has been the wealthy and powerful who have benefited off the Pacific Rim. They thrive off the informal trade agreements which support the exploitation and oppression of workers, women, migrants, and indigenous.

In Asia I have heard firsthand from those impacted by the practice of APEC. Multinational corporations reap their profits by keeping labor costs low, ignoring health and safety and practicing retaliation and repression when workers dare to speak up for their rights.

Under APEC, women have been channeled into industries designated as "low skilled" resulting in low pay, long hours, injuries and illness, stress, lack of rest days and holidays. This now includes women working on AI programs starting at the computer screen for hours at a time with no breaks.

Environmentally, seven out of ten of the world's top CO2 emitting emissions are members of APEC. Lax environmental protection language has allowed increased deforestation of sacred forests and pollution from mining and other extractive activities has poisoned the land and water.

Globally APEC's actions result in zillionaire profits for the wealthy alongside inhumane conditions for its most vulnerable and the exploitation of the environment. It is important that the Summit notes that in SF communities like Samoans, Tongans, Chamoru, Fijians and Hawaiians are Indigenous people of the Pacific and decisions that APEC makes will greatly affect their lives here in SF. Their voices must be sought out about the use of their lands that they

have stewarded for time immemorial.

APEC's plan for November's Summit reflects the same inhuman approach. Following the passage of this measure, the Mayor and City needs to move quickly to concretely work with community representatives to solve the harms and disruption posed by the Summit.





Honorable Supervisors:

The elders of our Yerba Buena Neighborhood are very alarmed. We all live inside the lock-down APEC security zone.

Despite many months leading up to this mega event the city has done no proper planning at all to, first, learn about, and second then plan for, the logistical needs for access and services for the 2000 seniors living in the 8 residences in YBC neighborhood (diagram attached). No one ever reached out to us in recent months. This is totally inept. This needs to be done ASAP.

The practical issues that need to be addressed and made to work include:

- Paratransit services access to the front doors (or alternative back door location) for each of the 8 senior residences and the Steppingstone Adult Day Health Center on Mabini Street.
- Taxi/rideshare access to the front doors (or alternative back door location) for each of the 8 senior residences throughout the day for residents' necessary trips to other locations in the City, especially those with mobility impairments. Very, very few own a car. And also for family resident pick ups/drop offs.
- 24 hour access to the 8 residencies for all building staff (more than 100 workers), and for chore workers and other in-home support service providers.
- No delays to meal lunch program food delivery access to several meal sites (so cooked food won't get cold – going to Pier 27 first cannot work) and Meals on Wheels access throughout the day.
- While most deliveries, service calls, move-ins/outs, etc etc. for the 8 residences can be rescheduled to avoid APEC there will be exceptions.
- Well over half of the seniors are Chinese elders, so bi-lingual assistance is necessary at all access points.

In general, procedures that may work for the residents of the condos and apartment buildings in the area, which seems to be the current City/Secret Service approach, will not suffice for the special circumstances of the elderly and their supportive residences. Without careful advance planning, and

continual on-site information sharing with our staff and residents, many will find themselves in house arrest for days.

And during APEC there has to be a single designated city contact we can call for real-time problem solving when something comes up.





THE YERBA BUENA "SENIOR VILLAGE'



About 2,000 elders now live in 8 senior residences within the larger Yerba Buena Neighborhood. Most are immigrants – more than half are Chinese, along with large Filipino and Russian groups – and their average age is now nearly 80 years. Almost 2/3 are women. After 25 years of persistent efforts by community members and (some) public officials to add support services and build a real Neighborhood where none was originally intended, the result is:
