10 WHEREAS, Upon completion of a competitive selection process, on August 15, 2023,
11 by Resolution No. 23-0198, the Airport Commission (Commission) awarded the Foreign
12 Currency Exchange Services Lease, Lease No. 23-0198 (Lease) to Lenlyn LTD. dba ICE
13 Currency Services USA; and

14 WHEREAS, The Lease has a term of four years with two 1-year options to extend at
15 the Commission's sole discretion, and an initial minimum annual guarantee of \$1,000,000;
16 now, therefore, be it

17 RESOLVED, That this Board of Supervisors hereby approves the Foreign Currency
18 Exchange Services Lease, Lease No. 23-0198, a copy of which is on file with the Clerk of the
19 Board of Supervisors in File No. 230913; and, be it

20 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed by
21 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for
22 inclusion into the official file.
