3	Resolution adopting findings under the California Environmental Quality Act (CEQA),
4	CEQA Guidelines and San Francisco Administrative Code Chapter 31, including the
5	adoption of a mitigation monitoring and reporting program and a statement of
6	overriding considerations in connection with the development of Treasure Island/Yerba
7	Buena Island, as envisioned in the Development Plan for the Treasure Island/Yerba
8	Buena Island Project Area.

10	WHEREAS, The Treasure Island / Yerba Buena Island Project Area comprises 550
11	acres of property, which includes portions of both Treasure Island and Yerba Buena Island,
12	excluding a 37 acre, federally owned U.S. Department of Labor Job Corps site and the
13	eastern portion of Yerba Buena Island ("Project Area"); and,
14	WHEREAS, The Planning Department ("Department") and TIDA have undertaken a
15	planning and environmental review process for the proposed Project Area and provided for
16	appropriate public hearings before the Planning Commission and the TIDA Board of Directors;
17	and,
18	WHEREAS, The actions listed in Attachment A ("Actions") are part of a series of
19	considerations in connection with the Development Plan for the Treasure Island/Yerba Buena
20	Island Project Area (collectively, the "Project"), as more particularly defined in Attachment A;
21	and,
22	WHEREAS, On July 12, 2010, the Department and TIDA released for public review
23	and comment the Draft Environmental Impact Report for the Project, (Department Case No.
24	2007.0903E); and,

1 WHEREAS, The Planning Commission and TIDA held a special joint hearing on 2 August 12, 2010 on the Draft Environmental Impact Report and received written public 3 comments until 5:00 pm on September 10, 2010, for a total of 60 days of public review; and, 4 WHEREAS, The Department and TIDA prepared a Final Environmental Impact Report 5 ("FEIR") for the Project consisting of the Draft Environmental Impact Report, the comments 6 received during the review period, any additional information that became available after the 7 publication of the Draft Environmental Impact Report, and the Draft Summary of Comments 8 and Responses, all as required by law. Copies of said documents are on file with the Clerk of the Board in File No. _____, and are incorporated herein by reference; and, 9

WHEREAS, The FEIR files and other Project-related Department and TIDA files have
been available for review by this Board of Supervisors and the public, and those files are part
of the record before this Board of Supervisors; and,

13 WHEREAS, On April 21, 2011, the Planning Commission and the TIDA Board of 14 Directors reviewed and considered the FEIR and, by Motion No. _____ and Resolution No. 15 _____, respectively, found that: (1) the contents of said report and the procedures through 16 which the FEIR was prepared, publicized and reviewed complied with the provisions of the 17 California Environmental Quality Act ("CEQA") and the CEQA Guidelines and Chapter 31 of 18 the San Francisco Administrative Code; (2) the FEIR was adequate, accurate and objective, reflected the independent judgment and analysis of each Commission and that the summary 19 20 of Comments and Responses contained no significant revisions to the Draft Environmental 21 Impact Report; and (3) the Project will have significant and unavoidable project impacts and 22 make a considerable contribution to cumulative impacts in the areas of transportation, noise, 23 air quality and historic resources; and,

WHEREAS, By said Motion and Resolution, the Planning Commission and the TIDA

4 WHEREAS, The Department and TIDA prepared proposed environmental findings, as 5 required by CEQA (the "CEQA Findings"), regarding the rejection of alternatives; mitigation 6 measures; significant environmental impacts analyzed in the FEIR; and overriding 7 considerations for approving the Project, including all of its Actions, among other topics. The 8 CEQA Findings also include a proposed mitigation monitoring and reporting program, denoted 9 as Attachment B. These CEQA findings, the Board of Supervisors' CEQA Findings, and 10 related Project documents were made available to the public and this Board of Supervisors for 11 the Board's review, consideration, and actions. 1 FURTHER RESOLVED, That the Board of Supervisors finds that (1) modifications 2 incorporated into the Project and reflected in the Actions will not require important revisions to 3 the FEIR due to the involvement of new significant environmental effects or a substantial 4 increase in the severity of previously identified significant effects; (2) no substantial changes 5 have occurred with respect to the circumstances under which the Project or the Actions are 6 undertaken that would require major revisions to the FEIR due to the involvement of new 7 significant environmental effects, or a substantial increase in the severity of effects identified 8 in the FEIR; and (3) no new information of substantial importance to the Project or the Actions 9 has become available that would indicate (a) the Project or the Actions will have significant 10 effects not discussed in the FEIR; (b) significant environmental effects will be substantially 11 more severe; (c) mitigation measures or alternatives found not feasible, which would reduce 12 one or more significant effects, have become feasible; or (d) mitigation measures or 13 alternatives, which are considerably different from those in the FEIR, would substantially 14 reduce one or more significant effects on the environment; and, be it 15 FURTHER RESOLVED, That the Board of Supervisors has reviewed and considered 16 the FEIR and hereby adopts its CEQA Findings, including the mitigation monitoring and 17 reporting program, contained in Attachment B, and the statement of overriding considerations. 18 19 20 21 22 23 24 25 Mayor Lee
