Hi Neighbors!

You have probably heard that the Westwood Park Association is in the process of requesting the SF Board of Supervisors (BOS) to approve the landmarking of our Entrance Gates on Miramar Avenue @ Monterey Boulevard, along with the four existing, original pillars in the neighborhood.

On Tuesday, January 23, the BOS will hold the first vote on the proposal. We need WP residents to send them a brief letter of support for the landmark designation.

Just to refresh your memory, the Entrance Gates were designed in 1916 by Louis Christian Mulgardt, a prominent architect in the early 1900s. Among other things, Mulgardt designed the home of the president of Stanford University, the redesign of the DeYoung Museum and the Infant Shelter at 19th & Ortega - which is now a French school, and SF Landmark #242.

Matching Entrance Gates on Miramar Avenue @ Ocean Avenue were built at the same time (1916), but are no longer in existence. We don't want to lose the remaining historic Entrance Gates and pillars, but to protect them with a landmark designation.

Supervisor Myrna Melgar's office is leading the charge to support landmarking, especially because there are very few official SF Landmarks in the western part of the City.

Dear Supervisors:

At the Land Use Committee hearing considering this application, a supervisor expressed uneasiness over landmarking the Westwood Park ("WPA") pillars because of the exclusionary language routinely written into CC&R's by developers in the early 1900's.

In 1992 Westwood Park residents shared that uneasiness and did something about it by refiling our CC&R's with the offensive covenant deleted. Each and every Westwood Park resident was notified and offered a copy of the refiled CC&R's. (See attached 1992 article from the WPA newsletter)

By approving the current application for approval of landmark status for the pillars, the Board of Supervisors has the opportunity to incent other planned unit developments to do the same.

I have been a Westwood Park resident for 40 years and both a member or President of the WPA Board of Directors for some 30 years. I also served as a San Francisco Planning Commissioner from 1996-2001 and have experience in the issues raised by landmarking.

My family and I purchased our home in 1983.

We were drawn to Westwood Park because of its affordability, access to public schools and sense of community. My husband and I, as first generation Americans and children of working- class families growing up in diverse New York City neighborhoods, felt at home in this working- class neighborhood.

That sense of community also led me to run for and serve (except for my time on the SF Planning Commission) on the WPA Board for some 30 years.

While serving on the WPA Board, I dealt with many issues impacting our community.

One was the maintenance and renovation of the pillars leading into Westwood Park.

Another, and much more personal, was the refiling of our CC&R's to eliminate the racist covenant routinely written into CC&R's back when Westwood Park was developed.

Little did I know that those two very separate issues would converge.

Based on my experience as a planning commissioner, from a land use perspective, landmarking the pillars is noncontroversial. This is reflected not only by the unanimous recommendation of the SF Landmarks Board but also the fact that when the pillars were in need of renovation, WPA made the case to SF Beautiful for their preservation and received a grant to restore and renovate them. (See attached WPA newsletter article Spring 2001)

That said, I appreciate the concern expressed that something should be done to acknowledge the racist covenant. At the same time, it should be acknowledged that Westwood Park deleted it.

Eliminating the offensive covenant was done in 1992 after Norman Yee - long before he became a supervisor - raised it at the first annual meeting he attended after he had purchased his home. He described the pain of reading it as part of the purchase process.

We realized that even though that covenant was no longer enforceable, that did not address the issue Norman had raised. Without the means to hire a lawyer (our dues were \$ 60 per year with the bulk going to maintenance of common areas and trees) a committee was formed and volunteers did research into eliminating the covenant entirely. We redrafted the CC&R's to delete that covenant and I personally filed them with the San Francisco Recorder.

It is my understanding that we are the only subdivision to have done so.

It is important to note that this step was beyond what was legally required of us since Civil Code Sections 53 and 782 only required a cover page to the CC&R's stating that covenant was no longer enforceable.

The law clearly supports the landmarking of the pillars. The Landmarking Commission got it right.

As for the discomfort of landmarking the pillars, we concede that while Westwood Park could erase that foul language, we couldn't erase that history.

But we could and did take a positive step to shape the future.

Approval of this motion presents a similar opportunity for the Board. Approving the motion because it BOTH meets the relevant architectural standards AND because WPA took steps to delete that offensive language of its CC&R's will incent other subdivisions to do the same.

That would be a constructive resolution of this sensitive issue and one that will inure to the benefit of folks like Norman Yee who would no longer be subject to the indignity of reading it.

Over the last few years an effort to plan and pay for the much-needed restoration of the Monterey/Miramar entrance gates to Westwood Park has finally come to fruition. Anita Theoharis was instrumental in securing a \$5,000 grant for the restoration from San Francisco Beautiful, an organization dedicated to creating, enhancing and protecting civic beauty. A factor I particularly appreciate as a long-term San Francisco resident active in the Westwood Park (President, Westwood Park Association 2009-2016), Ocean Avenue, Oceanview, Merced, Ingleside (OMI), Lakeside, and Excelsior communities.

I urge the Land Use Committee to approve Resolution initiating landmark designation under Article 10 of the Planning Code of the Westwood Park Entrance Gates, located at the intersection of M iramar Avenue and Monterey Boulevard and the Westwood Park Entrance Pillars located at the intersection of Miramar Avenue and Ocean Avenue.

Dear Members of the Board of Supervisors -

My family has resided in Westwood Park for the past 40 years. My paternal ancestors were lured to California during the days of the Gold Rush, but eventually settled in San Francisco.

At that time, the neighborhood of Westwood Park was just a dream. The 1906 earthquake shook the City, and residents left in droves. In an attempt to bring them back, the City fathers and developers realized that homes needed to be built for middle class residents. Westwood Park was one of those neighborhoods. In 1917, the first home in Westwood Park was finished. Today, the majority of our more than 650 homes are 100-years-old.

Louis Christian Mulghart, a prominent architect of the era, was hired by the developer in 1916 to design two Entrance Gates: Miramar Avenue @ Ocean Avenue and Miramar Avenue @ Monterey Boulevard. Sadly, the Miramar Avenue @ Ocean Avenue Gates no longer exist - a victim of "progress."

In order to protect the 108-year-old remaining, historic Entrance Gates and pillars in Westwood Park, I am urging you to approve our landmarking application.

Dear Members of the Board of Supervisors:

The Westwood Park Homeowners Association wholeheartedly supports the designation of the entrance pillars at Miramar/Ocean, Miramar/Monterey, and Flood/Frida Kahlo as San Francisco historic landmarks.

Our entrance pillars were designed by the renowned architect Louis Christian Mullgardt. Among the notable contributions to San Francisco, Mullgardt designed the 1912 Pan-Pacific International Exposition's Court of Ages and the redesigned former DeYoung Memorial Museum. Welcoming San Franciscans to a new master-planned residence park neighborhood after the completion of the West Portal tunnel, the pillars have stood for over a century.

In 1996, the City of San Francisco officially designated Westwood Park as a Residential Character District, acknowledging its unique architectural and topographic features.

Today, Westwood Park is one of the largest homeowners' associations in San Francisco with 685 homes, populated by race/ethnicity that is very reflective of the Citywide population (according to the 2020 Census). Our neighborhood, located near City College, continues to welcome new residents every month.

The designation of the Westwood Park pillars will be a proud reminder of San Francisco's history and serve as an honored landmark in District 7.
