NATURE OF THE CONTRACT (Please describe)  This is a proposed loan amendment to the borrower in support of the 100% affordable housing project at 78 Haight Street to meet the increase in Project costs caused by a delay in construction due to unforeseen conditions of the adjacent property, as well as other increased hard and soft costs to restart the Project which has been on pause since May 2022. This additional funding will support the 63 affordable new construction units of which 32 units will be targeted to homeless or at-risk transitional age youth.
