

| 3  | Resolution condemning anti-abortion harassment in San Francisco and affirming           |
| 4  | that the City and County of San Francisco has and will continue to stand in             |
| 5  | solidarity with health care providers and patients.                                     |

| 7  | WHEREAS, There are approximately 10 reproductive health care centers that               |
| 8  | operate in the City and County of San Francisco; and                                    |
| 9  | WHEREAS, Reproductive health care centers provide essential health care                 |
| 10 | services, especially for more vulnerable populations whose access to care is otherwise  |
| 11 | limited; and  |
| 12 | WHEREAS, In March of 2022, a group of anti-abortion protesters invaded the              |
| 13 | Women's Options Center at San Francisco General Hospital and were later charged         |
| 14 | with felony stalking and misdemeanors for obstructing freedom to access a clinic,       |
| 15 | vandalism, trespassing and other offenses; and  |
| 16 | WHEREAS, Planned Parenthood Northern California (PPNorCal) has                          |
| 17 | experienced a documented increase in protester activity since September 2023; and       |
| 18 | WHEREAS, PPNorCal's San Francisco location provides critical reproductive               |
| 19 | health care services including: Abortion Services; Birth Control; HIV Testing; PrEP and |
| 20 | PEP; Emergency Contraception; Pregnancy Testing & Services; STI Testing;                |
| 21 | Vasectomies; Treatment & Vaccines; and Gender Affirming Hormone Therapy; and            |
| 22 | WHEREAS, In PPNorCal's 2023 Fiscal Year (July 1, 2022, to June 30, 2023) the            |
| 23 | San Francisco Health Center had 16,750 patient encounters; they conducted 35,921        |
| 24 | STI tests and treatments, and managed 4,934 contraception visits, 1,947 emergency       |
| 25 | contraception visits, and 6,464 pregnancy tests; and                                    |

Supervisor Stefani BOARD OF SUPERVISORS WHEREAS, Organized protests and rallies, such as "40 Days for Life" and the
 "March for Life " incite opportunities for extremists to harass, intimidate, and threaten
 bodily harm to health care providers and patients; and

WHEREAS, The "40 Days for Life" organizers have identified PPNorCal's San
Francisco Health Center as a "vigil" location for their winter campaign beginning on
Wednesday, February 14, 2024; and

WHEREAS, In 1993, the San Francisco Board of Supervisors adopted Police
Code, Article 43, establishing that "Maintaining access to reproductive health care
services is a matter of critical importance not only to individuals, but also to the health,
safety, and welfare of all residents of the City" and finding the law "necessary to
promote the full exercise of the right to privacy by patients seeking vital reproductive
health care services and is also necessary to maintain public health, safety, and welfare
within the City;" and

WHEREAS, In 1994, the United States Congress enacted the "Freedom of
Access to Clinical Entrances" (FACE) Act, prohibiting violent, threatening, damaging
and obstructive conduct intended to injure, intimidate, or interfere with the right to seek,
obtain, or provide reproductive health services; and

WHEREAS, In 2022, voters in California approved Proposition 1, an amendment
to the state constitution that "the state shall not deny or interfere with an individual's
reproductive freedom in their most intimate decisions, which includes their fundamental
right to choose to have an abortion and their fundamental right to choose or refuse
contraceptives;" and
WHEREAS, In a 2022 report, the National Abortion Federation ("NAF") found that

24 abortion providers reported a significant increase in violence and disruption against

staff; stalking of staff and patients rose 229% from 2021 to 2022 and burglary of health
 centers rose 231% from 2021 to 2022; and

WHEREAS, The report noted that there has been a "sharp increase in violence
and disruption in states that are protective of abortion rights", assault and battery
increased by 29% from 2021 to 2022, burglaries increased by 100% from 2021 to 2022,
and stalking increased by 913% from 2021 to 2022; and

WHEREAS, The Security Director of NAF has also asserted that "The threat of
violence against abortion providers remains on the rise and is extremely concerning. In
addition to an increase in major incidents, extremists are becoming more organized; for
example, we're seeing them target clinics on days when they know they will have more
patients, are less staffed, or have less security;" and

12 WHEREAS, In 2021, the California Legislature enacted Assembly Bill No. 1356, 13 which declared in part that, "[a]cts of violence and harassment against abortion 14 providers have persisted in the decades since Roe v. Wade, 410 U.S. 113 (1973), and 15 reproductive health centers are seeing an increase in threats and security incidents, as 16 existing laws have not sufficiently deterred anti-abortion extremists;" the bill ensures 17 "that people who need access to family planning and other sexual and reproductive 18 health care services can do so confidentially and in a timely manner without 19 harassment, threats, or fear of bodily harm;" and 20 WHEREAS, On June 7, 2022, the U.S. Department of Homeland Security 21 ("DHS") issued a National Terrorism Advisory System bulletin noting that "[g]iven a high-22 profile U.S. Supreme Court case about abortion rights, individuals who advocate both

for and against abortion have, on public forums, encouraged violence, including against

24 reproductive healthcare personnel facilities, as well as those with opposing ideologies;"

| 3  | conduct directed at reproductive health care providers; and                                |
| 4  | WHEREAS, The Board of Supervisors unanimously declared via Resolution No.                  |
| 5  | 201-22, San Francisco to be a champion of reproductive freedom and justice; and            |
| 6  | WHEREAS, The San Francisco Board of Supervisors recognizes that the right to               |
| 7  | free speech must be upheld but that it should not come at the cost of impeding a           |
| 8  | person's right to seek health care; now, therefore, be it                                  |
| 9  | RESOLVED, That the San Francisco Board of Supervisors urges the San                        |
| 10 | Francisco Police Department and the City Attorney's Office to fully implement and          |
| 11 | enforce Article 43 of the law; and, be it  |
| 12 | FURTHER RESOLVED, That the San Francisco Board of Supervisors urges the                    |
| 13 | San Francisco Police Department to, where appropriate, coordinate responses with the       |
| 14 | local Federal Bureau of Investigation; and, be it  |
| 15 | FURTHER RESOLVED, That the San Francisco Board of Supervisors                              |
| 16 | unequivocally condemns all forms of harassment against individuals seeking                 |
| 17 | reproductive health care; and, be it   |
| 18 | FURTHER RESOLVED, That the City and County of San Francisco has and will                   |
| 19 | continue to stand in solidarity with health care providers and patients who have the right |
| 20 | to provide and seek care without fear of harassment, threat of intimidation, or fear of    |
