6 **Shally Nguyen and Kyle Ravelo v. City and County of San Francisco; the lawsuit**
7 **involves alleged personal injury arising from collision with City vehicle.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Shally Nguyen and Kyle Ravelo v. City
12 and County of San Francisco, San Francisco Superior Court, Case No. CGC-22-602620 by
13 the payment of \$35,000. The lawsuit involves alleged personal injury arising from collision
14 with City vehicle.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 October 26, 2022, and the following parties were named in the lawsuit: Plaintiffs Shally
17 Nguyen and Kyle Ravelo; Defendant City and County of San Francisco.
