6 **and County of San Francisco, et al.; the lawsuit involves alleged personal injury on a**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes
10 the City Attorney to settle the action entitled Mason Masuda v. City and County of San
11 Francisco, et al., San Francisco Superior Court, Case No. CGC-23-606369 by the payment of
12 \$9,000,000. The lawsuit involves alleged personal injury on a City street.

13 Section 2. The above-named action was filed in San Francisco Superior Court on May
14 9, 2023, and the following parties were named in the lawsuit: Plaintiff Mason Masuda;
