11 WHEREAS, Domaine SF LLC, is seeking the issuance of a Type-42 on-sale beer
12 and wine liquor license to do business as Domaine SF, located at 2331 3rd Street

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of
17 support with the Department of Alcoholic Beverage Control under California Business
18 and Professions Code, Section 24013, and recommends that the Department of
19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the

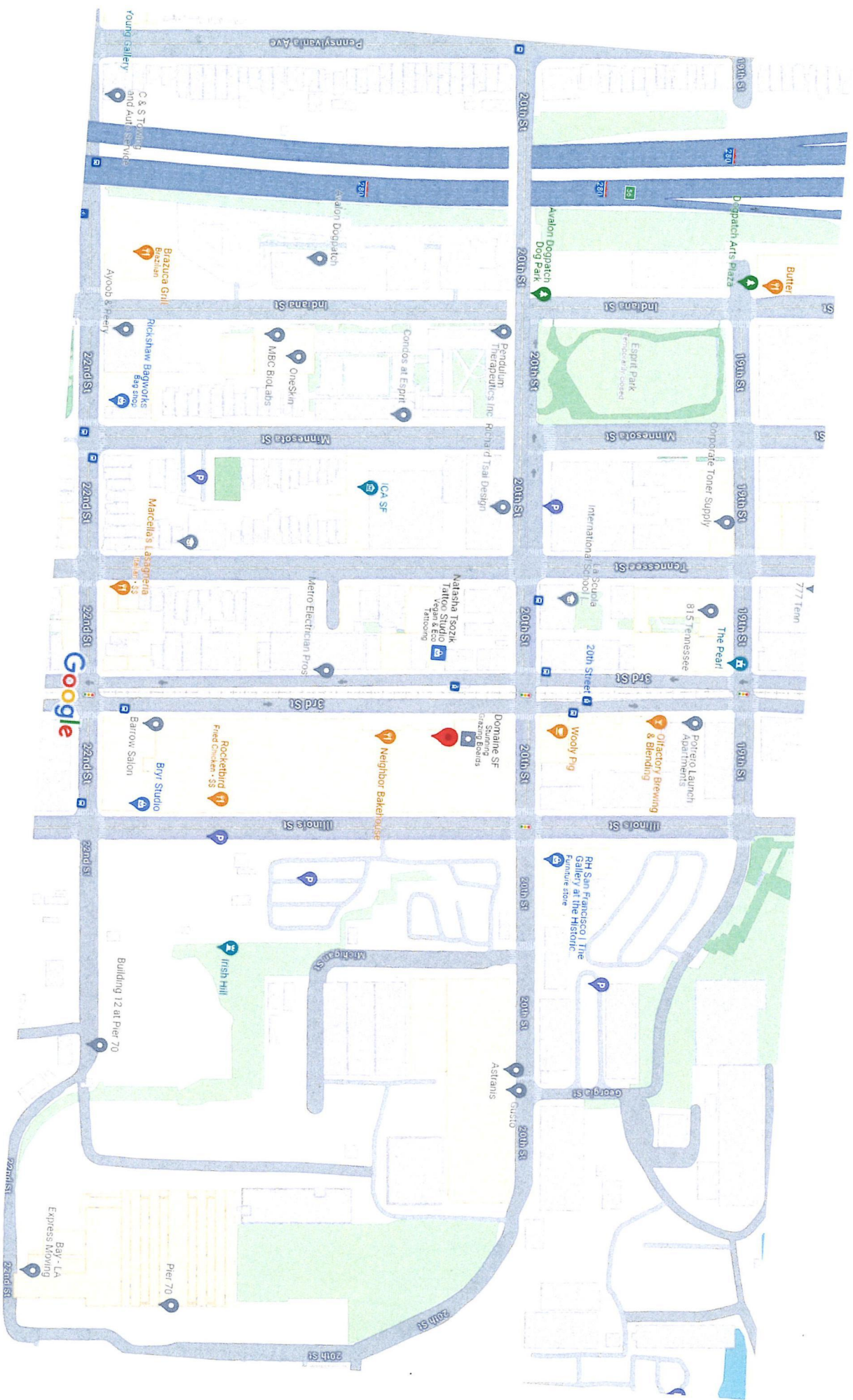

The Planning Department recommends approval for a new type 42 proposed at 2331 03rd Street, located in the Innovated Industries Special Use District per Planning Code Section 249.37(c)(2) and 210.3. Retail Sales and Services (includes a Bar use) are principally permitted. Public notice is not required per the planning code in this case. Please see the attached planning department recommendation.

SEC. 249.37. INNOVATIVE INDUSTRIES SPECIAL USE DISTRICT.

(a) **Purpose.** The purpose of the Innovative Industries Special Use District is to provide affordable office space to small firms and organizations which are engaged in innovative activities, including incubator businesses and microenterprises.

(b) **Geography.** The boundaries of the Innovative Industries Special Use District are shown on Sectional Map No. 8SU of the [Zoning Map](#).

(c) **Controls.** All provisions of the Planning Code currently applicable shall continue to apply, except that:

(1) office uses shall be principally permitted uses on all stories above the ground story.

(2) retail uses shall be subject to the size controls applicable in the Urban Mixed Use District, as stated in Sec. 843.45.

Dear San Francisco Board of Supervisors:

Domaine SF LLC seeks to do business as an all-natural wine and cheese board catering shop in Dog Patch at the above address, 2331 3rd St., SF, CA 94107. In addition to selling organic/all-natural/biodynamic wines for consumption off premise, we will hold weekly, on-premise, wine tasting events. The business will be open 6 days a week from 11am to 7pm (closed on Mondays).

On March 28, 2024, I, Keri Johnson, applied in-person at the ABC Office located at 33 New Montgomery St., for a new issuance of an **ABC Type 42 license**, which authorizes the sale of beer and wine for consumption on or off the premises where sold.

On April 4, 2024 the ABC Notification Poster was conspicuously mounted on the property window. In addition on 4/4/24, notices were mailed out to all residents and real property owners within a 500' radius of the proposed retail premises. This mailing was completed by Direct Mail Center, located at 1099 Mariposa St.

About Domaine SF

Domaine SF is a retail concept that aims to be an authority for natural wine in the Bay Area. We will sell natural wine, local artisan foods, cheese & charcuterie boards for take-out. We will also host wine tasting and food pairing events featuring the growers, producers and makers we support in our store.

Our goal is to bring together people seeking a better life through gastronomy with ethical growers, food artisans and small production wine makers who prioritize craftsmanship and sustainability above all else. Our specialty is natural wine, which means wine free of stabilizers and other additives and produced using grapes grown pesticide-free respecting the cycles of nature. We will represent small-producers and stock natural wines from regions all over the world, creating one of the most expansive and diverse natural wine offerings in the Bay Area.

Beyond wine, we will offer cheese & charcuterie grazing boards and crated gift sets. We will have a small marketplace featuring the local foods, organic produce, and artisan craftworks we incorporate into our grazing boards and our farm-to-table gift boxes.

Currently Dog Patch does not have a dedicated natural wine merchant. There are several wine bars and restaurants in the neighborhood, but not a dedicated retail experience where the community can learn about and try natural wine and purchase bottles for off-premise consumption. We are planning to merchandise close to 300 labels, making Domaine SF a destination for wine lovers all over the Bay Area. For the local community, we hope to become a hub for gatherings and community building.

It is my sincere hope that the Board of Supervisors will approve the issuance of an ABC Type 42 license for this location.
