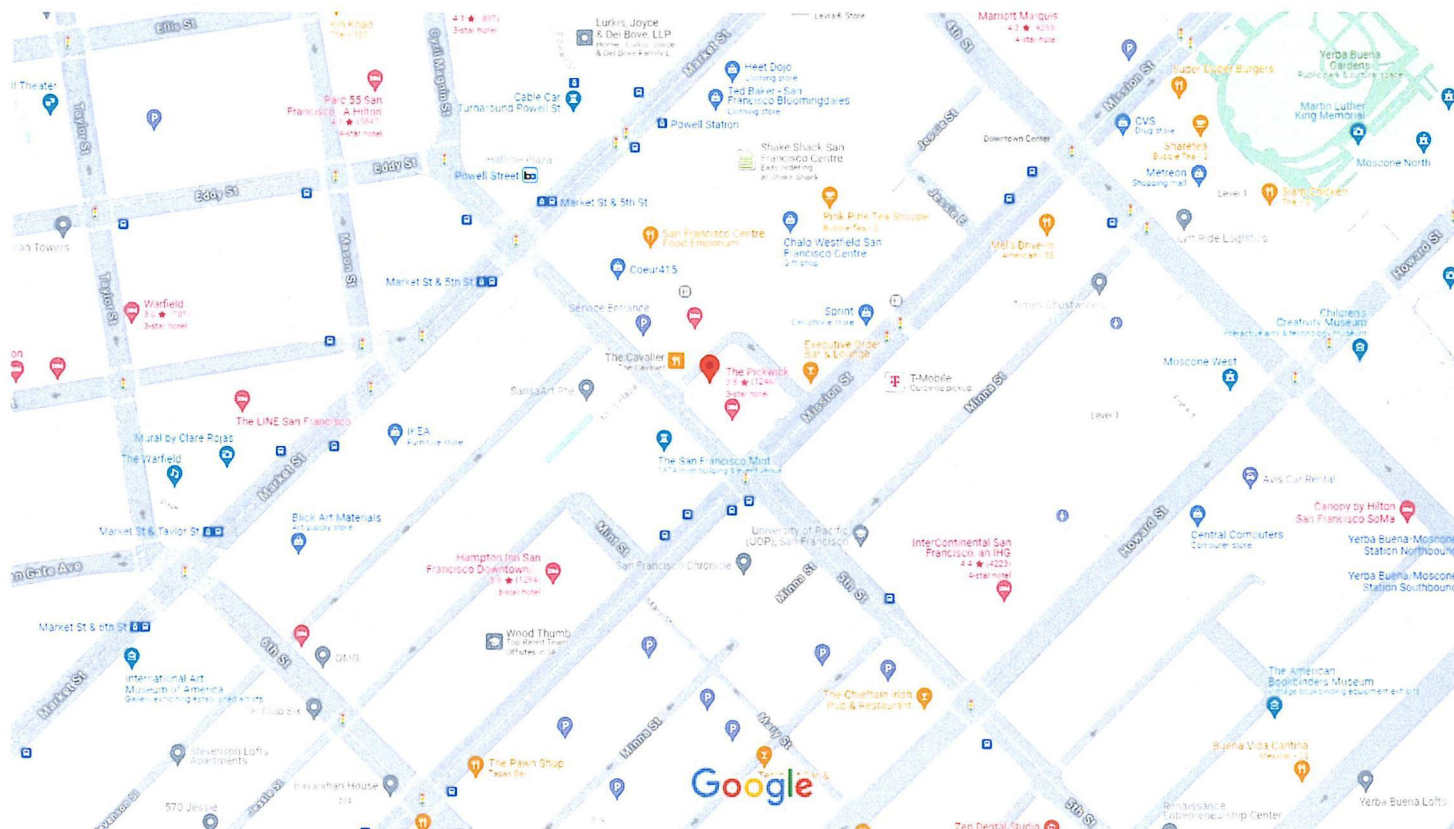
1. Petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as depicted on the ABC-253.
2. The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control, as depicted on ABC-253.
3. (1) Except as provided in Condition 2 below, no noise shall be audible beyond the area under the control of the licensee. (SF district office only).

(2) Any noise caused by entertainment or amplified sound that is subject to the provisions of an active Entertainment Permit issued by the San Francisco Entertainment Commission shall be authorized in accordance with the limits established by that Entertainment Permit, including any limitation on hours during which entertainment or amplified sound is permitted. A violation of the entertainment or amplified sound noise conditions of the Entertainment Permit, as determined by the San Francisco Entertainment Commission (or any successor agency), shall be deemed to be a violation of this Condition. Any noise that is not subject to, or is beyond the scope of, the Entertainment Permit shall be subject to

Condition 1 above. "Entertainment Permit" means any of the following: a Just Add Music permit, a Limited Live Performance permit, a Place of Entertainment permit, a Fixed Place Amplified Sound permit, or any similar such permit issued by the San Francisco Entertainment Commission. (SF district office only).

4. At any time, the premise is providing live entertainment, the petitioner(s) shall have two (2) uniformed security guard(s) on the premises and shall maintain order therein to prevent any activity which would interfere with the quiet enjoyment of their nearby residents, or the surrounding community. The uniform security guards must be licensed by the State of California Department of Consumer Affairs.



Create new jobs: Currently, our operating hours only extend until 3 pm each day. With a license, we plan to keep the establishment open until midnight, requiring over 8 additional employees for evening shifts. This extended operating schedule will allow us to better serve patrons while providing new job opportunities.

Aid downtown's hotel/convention rebound: As major hotels and the Moscone Convention Center ramp back up, having a diverse, vibrant array of dining and nightlife options is crucial for accommodating visitors and creating a hospitable

In many ways, granting our license can be a catalyst for downtown San Francisco's continued recovery and revitalization in the post-COVID era. We aim to play a responsible role in reactivating this vital neighborhood both day and night.

Attract more visitors and residents downtown: With a lively bar and restaurant scene, more people will be drawn to spend time and money in the downtown area in the evenings and on weekends. A diverse array of dining and nightlife options creates an appealing environment that encourages people to linger.

Support downtown's economic recovery: Businesses with licenses tend to generate more revenue than those without, through bar sales and longer visitor dwell times. This increased economic activity is vital for financially sustaining downtown small businesses impacted by the pandemic.

Activate downtown's street life: An energetic bar and restaurant row contributes significant pedestrian activity and street-level atmosphere. This enhanced vibrancy and sense of safety encourages more people to visit and explore the downtown district.

Cater to downtown's residential population: The downtown area continues to see growth in its number of urban residential units. A licensed establishment provides an important neighborhood amenity for these downtown dwellers.
