3 **Ordinance authorizing settlement of the lawsuit filed by Jean Agustin against the City**  
4 **and County of San Francisco for \$75,000; the lawsuit was filed on February 1, 2023, in**  
5 **San Francisco Superior Court, Case No. CGC-23-604409; entitled Jean Agustin v. City**  
6 **and County of San Francisco; the lawsuit involves alleged personal injury occurring on**  
7 **a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Jean Agustin v. City and County of  
12 San Francisco, San Francisco Superior Court, Case No. CGC-23-604409 by the payment of  
13 \$75,000. The lawsuit involves alleged personal injury occurring on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 February 1, 2023, and the following parties were named in the lawsuit: Plaintiff Jean Agustin;  
16 Defendant City and County of San Francisco.
