5 **filed on April 19, 2022, in San Francisco Superior Court, Case No. CGC-22-599250;**  
6 **entitled Rahul Seth, M.D. v. City and County of San Francisco, et al.; the lawsuit**  
7 **involves alleged personal injury on a City street.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Rahul Seth, M.D. v. City and County of  
12 San Francisco, et al., San Francisco Superior Court, Case No. CGC-22-599250 for the  
13 payment to the City of \$170,000. The lawsuit involves alleged personal injury on a City street.

14 Section 2. The above-named action was filed in San Francisco Superior Court on April  
15 19, 2022, and the following parties were named in the lawsuit: Plaintiff: Rahul Seth, M.D.;  
16 Defendants/Cross-Defendants/Cross-Complainants: Pacific Gas & Electric Company and City
