

1 [Liquor License Transfer - 340 Balboa Street - Tomorrows Wine]

3 **Resolution determining that the person-to-person, premise-to-premise transfer of**  
4 **a Type-20 off-sale beer and wine liquor license to Tofino Wines Inc., to do**  
5 **business as Tomorrows Wine, located at 340 Balboa Street (District 1), will serve**  
6 **the public convenience or necessity of the City and County of San Francisco, in**  
7 **accordance with California Business and Professions Code, Section 23958.4; and**  
8 **requesting that the California Department of Alcoholic Beverage Control impose**  
9 **conditions on the issuance of the license.**

11 WHEREAS, Tofino Wines Inc., is seeking the person-to-person, premise-to-  
12 premise transfer of a Type-20 off-sale beer and wine liquor license to do business as  
13 Tomorrows Wine, located at 340 Balboa Street (District 1); and

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of  
17 support with the Department of Alcoholic Beverage Control under California Business  
18 and Professions Code, Section 24013, and recommends that the Department of  
19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the  
21 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort  
22 to prevent the loitering of persons on any property adjacent to the licensed premises as  
23 depicted on the ABC-253; 2) The petitioner(s) shall be responsible for maintaining free  
24 of litter the area adjacent to the premises over which they have control, as depicted on  
25 ABC-253; and 3) When tasting is being conducted, there shall be signs in a

1 conspicuous space at the entrance and/or exits of the premise as depicted on the  
2 ABC-253, which will state "NO ALCOHOLIC BEVERAGES BEYOND THIS POINT".  
3 Said signs shall be no less than 7" x 11" in size and contain lettering no less 1" in  
4 height; now, therefore, be it

5           RESOLVED, That in accordance with California Business and Professions Code,  
6 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
7 hereby determines that the person-to-person, premise-to-premise transfer of a Type-20  
8 off-sale beer and wine liquor license to Tofino Wines Inc., doing business as Tomorrows  
9 Wine, located at 340 Balboa Street, will serve the public convenience or necessity of the  
10 City and County of San Francisco; and, be it

11           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
12 San Francisco hereby endorses and adopts the recommendations of the Police  
13 Department listed above and recommends that the Department of Alcoholic Beverage  
14 Control issue the license with those conditions.
