9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Sarah Perata v. City and County of
12 San Francisco, United States District Court, Northern District of California, Case No. 4:21-cv-
13 02819 by the payment of \$575,000. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in the United States District Court for
15 the Northern District of California on April 19, 2021, and the following parties were named in
16 the lawsuit: Sarah Perata, City and County of San Francisco.
